BY-LAW NO. 1948

A BY-LAW to amend "BURNABY WATERWORKS REGULATION
BY-LAW NO. 2, 1926."

THE MUNICIPAL COUNCIL of The Corporation of the District
of Burnaby ENACTS as follows:-

1. Schedule "A" to the said "Burnaby Waterworks
Regulation By-law No. 2, 1926" is hereby repealed and the schedule
hereunto annexed substituted therefor.

2. This By-law shall come into force upon receiving
the approval of the Lieutenant-Governor in Council.

3. This By-law may be cited as the "BURNABY WATERWORKS
REGULATION BY-LAW NO. 2, 1926, AMENDMENT BY-LAW 1947."

SCHEDULE "A" TO "BURNABY WATERWORKS
REGULATION BY-LAW NO. 2, 1926"

FLAT RATES

Nine (\$9.00) Dollars for each period of six (6) months subject to a discount of one (\$1.00) Dollar if paid on or before the 31st day of the month in which the same may be payable.

Eighteen (\$18.00) Dollars for each period of one (1) year subject to a discount of Two (\$2.00) Dollars if paid on or before the 1st day of May.

Duplex Houses

All duplex houses will be serviced by two flat services instead of a meter.

REGULATION BY-LAW NO. 2, 1926

FLAT RATES

Eleven Dollars and Fifty Cents (\$11.50) for each period of six (6) months subject to a discount of One (\$1.00) Dollar if paid on or before the last day of the month in which same may be payable.

Twenty three (\$23.00) Dollars for each period of one (1) year subject to a discount of Three (\$3.00) Dollars if paid on or before the first discount date in the year.

Twenty three (\$23.00) Dollars for each period of one (1) year subject to a discount of Two (\$2.00) Dollars if paid on or before the 1st day of May.

Duplex Houses

All duplex houses will be serviced by two flat services instead of a meter.
