

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1957

A BY-LAW to authorize the sale of certain Tax Sale lands belonging to the Corporation of the District of Burnaby, and to accept in part or full payment therefor, other lands in the Municipality.

WHEREAS the Corporation of the District of Burnaby has acquired under Tax Sale proceedings, lands and premises described as Lot Three (3) of Block Twenty one (21) of District Lot One hundred Fifty seven (157), Group One (1), New Westminster District, Map No. 1309.

AND WHEREAS James Ravis Hunt and Irene Myrtle Hunt, of the Municipality of Burnaby, Province of British Columbia, are the owners of lands and premises described as Lot Thirteen (13) of Block Seventeen (17) of District Lot Ninety Nine (99), Group One (1), New Westminster District, Map No. 4452.

AND WHEREAS the said James Ravis Hunt and Irene Myrtle Hunt have requested the Corporation to convey to them the said lands described as Lot three (3) of Block Twenty one (21) of District Lot One hundred Fifty seven (157), Group One (1), New Westminster District, Map No. 1309 and to accept in full payment therefor conveyance of the said Lot Thirteen (13) of Block Seventeen (17) of District Lot Ninety Nine (99), Group One (1), New Westminster District, Map No. 4452.

AND WHEREAS it is deemed advisable to effect such exchange of lands and premises.

THEREFORE the Council of the Corporation of the District of Burnaby ENACTS as follows:-

1. Upon the execution and delivery to the Corporation of the District of Burnaby by James Ravis Hunt and Irene Myrtle Hunt or a good and sufficient deed of the lands and premises described as Lot Thirteen (13) of Block Seventeen (17) of District Lot Ninety Nine (99), Group One (1), New Westminster District, Map No. 4452 free and

clear of all encumbrance whatsoever, the Reeve and the Clerk are hereby authorized and empowered to execute and set the official and Corporate Seal of the Corporation of the District of Burnaby to a Conveyance of lands and premises described as Lot Three (3) of Block Twenty one (21) or District Lot One hundred Fifty seven (157), Group One (1), New Westminster District, Map No. 1309 to the said James Ravis Hunt and Irene Myrtle Hunt, and to deliver such Conveyance when so executed to the said James Ravis Hunt and Irene Myrtle Hunt.

2. This By-law may be cited as "BURNABY PROPERTY EXCHANGE BY-LAW NO. 2, 1947."
