

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1970.

A BY-LAW to authorize the expenditure of \$20,000.00 for the acquisition of property and the removal of buildings for the widening of Hastings Street East in the 3700 Block, South side.

WHEREAS by By-law No. 1838 of The Corporation of the District of Burnaby, the sum of \$20,000.00 was set aside in trust for the specific purpose of widening Hastings Street East in the 3700 Block, South side.

AND WHEREAS the Council of The Corporation of the District of Burnaby deem it advisable to now proceed with the work of widening the said street.

THE MUNICIPAL COUNCIL of The Corporation of the District of Burnaby therefore ENACTS as follows:-

1. The sum of \$20,000.00 together with accrued interest thereon, set aside by By-law No. 1838 is hereby appropriated for the purpose of paying all costs incurred in the widening of the 3700 Block, Hastings Street, South side.

2. The Reeve and Clerk are hereby empowered to do all necessary acts and things to give effect to the transfer and use of funds hereby appropriated.

3. This By-law may be cited as "BURNABY RESERVE FUND BY-LAW 1944, EXPENDITURE BY-LAW 1947."
