BY-LAW NO. 1977

A BY-LAW to authorize the sale of Lot 6, Block 28,  
D.L. 187, Group 1, N.W.D., Map No. 1282.

WHEREAS The Corporation of the District of Burnaby has acquired all and singular those certain parcels or tracts of land and premises known as Lot Six (6) of Block Twenty-eight (28) District Lot One hundred and eighty-seven (187) Group One (1), New Westminster District, Map No. 1282, for Corporate purposes.

AND WHEREAS the said lands and premises are no longer required for Corporate purposes.

AND WHEREAS the value of the land and premises does not exceed the sum of Two thousand (\$2,000.00) dollars.

AND WHEREAS the hereinafter mentioned person has offered to purchase the said lands for the sum of Two hundred and twenty (\$220.00) dollars.

AND WHEREAS the Council of the Corporation of the District of Burnaby deem it advisable to accept the said offer.

NOW THEREFORE the Municipal Council of the Corporation of the District of Burnaby ENACTS as follows:-

1. That Lot Six (6) Block Twenty-eight (28) District Lot One hundred and eighty-seven (187) Group One (1), New Westminster District, Map No. 1282, be sold and disposed of to The Royal Trust Company of 626 Pender Street West in the City of Vancouver, Province of British Columbia, for the sum of Two hundred and twenty dollars (\$220.00)

2. That upon payment of the said sum of Two hundred and twenty (\$220.00) dollars, by the said The Royal Trust Company, Conveyance to the said The Royal Trust Company of Lot Six (6) Block Twenty-eight (28) District Lot One hundred and eighty-seven (187) Group One (1), New Westminster District, Map No. 1282, be executed under the Seal of the Corporation by the Reeve and Clerk and be delivered to the said The Royal Trust Company.

3. This By-law may be cited as "WILLIAM TEMPLE PROPERTY SALE BY-LAW 1947".
