BYLAW NO. 10465

A BYLAW to exempt from taxation certain lands and improvements pursuant to section 400(1) and (2)(c.1) of the Municipal Act

The Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as BURNABY TAXATION EXEMPTION BYLAW NO. 11, 1996.
  
2. Pursuant to section 400(1) and (2)(c.1) of the Municipal Act, Council does hereby exempt from taxation under section 273(a), (b) and (c) of the said Act for the year 1997 the interest in a municipal building of a non-profit organization that uses or occupies the building as a licensee or tenant of the City of Burnaby, namely:
  1. Burnaby Heights School - 250 S. Willingdon Avenue (Roll No. 5655-0250) more particularly described as Parcel 1, District Lots 122 and 188, Group 1, New Westminster District, Plan NWP87902, occupied by:
    - (a) Boy Scouts of Canada
    - (b) B.C. Amateur Boxing Association
    - (c) Burnaby Association for the Mentally Handicapped
    - (d) Burnaby Family Life Institute
    - (e) Burnaby Information and Community Services Society
    - (f) Burnaby Volunteer Centre Society
    - (g) Burnaby Multicultural Society
    - (h) Burnaby Seniors Outreach Services Society

- (i) C.A.S.I. (Comitato Attivita Scolastiche Italiane)
  - (j) Burnaby - New Westminster Childcare Support Program
  - (k) Voices for Survivors
2. Edmonds North Wing Community Resource Center - 7355 Canada Way (Roll No. 1770-7355) more particularly described as Lot A, District Lot 30, Group 1, New Westminster District, Plan NWP87763 except Plan LMP19140, occupied by:
- (a) St. Matthew's Day Care Society
  - (b) Deaf Children's Society of B.C.
  - (c) Burnaby Association for the Mentally Handicapped
  - (d) Canadian Mental Health Association
  - (e) St. John Ambulance, Burnaby Branch
  - (f) Burnaby Family Life Institute
  - (g) Canadian Red Cross, Fraser Region-Burnaby Branch
  - (h) St. Leonard's Youth & Family Services Society
