BYLAW NO. 10519

A BYLAW to authorize the construction of certain local improvement works upon petition

WHEREAS Council has received petitions to construct the local improvement works hereinafter described and the City Clerk has certified that the said petitions are sufficient;

AND WHEREAS it is expedient to grant the prayers of the said petitions in the manner hereinafter provided;

AND WHEREAS Council has had prepared the report required by section 662 of the Municipal Act;

AND WHEREAS the lifetime of the said works is twenty years;

AND WHEREAS the estimated cost of the said works is \$996,990.00;

AND WHEREAS the share or portion of the cost of the said works that should be borne by the parcels of land that abut or are deemed to abut on the said works is \$386,419.05;

AND WHEREAS the City's share or proportion of the cost of the said works is \$610,570.95;

AND WHEREAS the special charges should be made payable in fifteen annual instalments;

AND WHEREAS the total amount proposed to be borrowed under this Bylaw, namely \$996,990.00, does not exceed the total amount of borrowing approved by the Inspector of Municipalities for local improvement purposes less the amount already borrowed under such authorization;

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as BURNABY LOCAL IMPROVEMENT CONSTRUCTION BYLAW NO. 1, 1997.

2. The Council of the City of Burnaby is hereby authorized and empowered to construct as a local improvement under the provisions of Part 16 of the Municipal Act:

- (a) asphaltic pavement 8.5 m wide with curb and walk both sides and trees as required at the following locations:
 - (i) Grove Avenue from Union Street to Frances Street, flaring to 11 meters from Georgia Street to Frances Street,
 - (ii) Oxford Street from Rosser Avenue to Willingdon Avenue, flaring to 11 meters at Willingdon Avenue.
- (b) asphaltic pavement 8.5 m wide with curb and walk on the south side and curb and replacement walk on the north side and trees as required at the following locations:
 - (i) 16th Avenue from Mary Avenue to Canada Way, flaring to 11 meters at Canada Way,
 - (ii) 16th Avenue from Canada Way to 6th Street, flaring to 11 meters at Canada Way at 6th Street.
- (c) asphaltic pavement 8.5 m wide with curb and replacement walk both sides and trees
 as required at Cambridge Street from Carleton Avenue to Madison Avenue.

3. The Clerk is authorized and empowered to cause a contract for the construction of the said works to be made and entered into with some person or persons, firm or corporation, subject to the approval of Council to be declared by resolution.

4. The special charges shall be paid by fifteen annual instalments.

5. The Assessor shall forthwith prepare a frontage tax assessment roll in respect of the said works pursuant to section 483 of the Municipal Act and in accordance with the provisions of Bylaw No. 8417, as amended, and shall from time to time revise the said frontage tax assessment roll in accordance with subsection (3) of the said section 483.
