## CITY OF BURNABY

## **BYLAW NO. 10605**

A BYLAW to provide for the establishment of metered parking on certain streets

The Council of the City of Burnaby ENACTS as follows:

- This Bylaw may be cited as BURNABY PARKING METER BYLAW
  1998.
- 2. In this Bylaw, unless the context otherwise requires:
  - (a) "metered space" means an area of the curb lane of a street in a metered zone designated under Section 3 (1) for the parking of a single vehicle and for which a parking meter has been installed;
  - (b) "metered zone" means any street or portion of a street so designated by a resolution of Council on which parking meters may be installed and maintained to collect a fee for the parking of a vehicle;
  - (c) "park" means the stopping or standing of a vehicle, whether occupied or not;
  - (d) "parking meter" means a mechanical, electrical or automatic device installed in a metered zone pursuant to this Bylaw for the purpose of measuring and indicating a time during which a vehicle may be parked in a metered space;

- (e) "vehicle" means a device in, on or by which a person or thing is or may be transported or drawn on a street or highway, except a device designed to be moved by human power or used exclusively on stationary rails or tracks.
- 3. (1) The City's Director Engineering is hereby authorized to designate metered spaces and to install and maintain parking meters in metered zones.
- (2) Parking meters shall be placed upon and fastened to the curb or sidewalk adjoining each metered space and each parking meter shall indicate the time allowed for parking in such metered space.
- 4. No person shall park a vehicle in a metered space without immediately depositing in the parking meter installed for such space the fee for parking at the rate set out in Schedule "A" and in the manner indicated on the parking meter.
- 5. No person shall permit a vehicle to remain parked in a metered space for longer than the maximum time indicated on the parking meter or for longer than the time as measured by the parking meter for the amount of the fee deposited in the parking meter.
- 6. No person shall park a vehicle in a metered space
  - (a) at any time when the parking of vehicles at that location is otherwise prohibited; or
  - (b) when the parking meter is not functioning.

- 7. The Director Engineering may temporarily discontinue the use of a metered space for the parking of vehicles and may place at such metered space a sign indicating that parking is not permitted at that metered space and no person shall park a vehicle in such metered space while such sign is so placed.
- 8. It shall be unlawful for any person to park a vehicle in a metered space except as permitted by this Bylaw.
- 9. The owner of a vehicle parked in contravention of this Bylaw shall be liable for the penalties provided for any violation of this Bylaw with respect to the vehicle, but nothing in this section shall relieve the operator of a vehicle from incurring the penalties provided for such violation.
- 10. Every person who violates any of the provisions of this Bylaw commits an offence and shall be liable to payment of a fine not exceeding One Hundred (\$100.00) Dollars.
