BYLAW NO. 10646

A BYLAW to authorize the construction of certain local improvement works upon petition

WHEREAS Council has received a petition to construct the local improvement works hereinafter described and the City Clerk has certified that the said petition is sufficient;

AND WHEREAS it is expedient to grant the prayer of the said petition in the manner hereinafter provided;

AND WHEREAS Council has had prepared the report required by section 635 of the *Municipal Act*;

AND WHEREAS the lifetime of the said works is twenty years;

AND WHEREAS the estimated cost of the said works is \$230,400.00;

AND WHEREAS the share or portion of the cost of the said works that should be borne by the parcels of land that abut or are deemed to abut on the said works is \$160,763.10;

AND WHEREAS the City's share or proportion of the cost of the said works is \$69,636.90;

AND WHEREAS the special charges should be made payable in ten annual instalments;

AND WHEREAS the total amount proposed to be borrowed under this Bylaw, namely \$230,400, does not exceed the total amount of borrowing approved by the Inspector of Municipalities for local improvement purposes less the amount already borrowed under such authorization;

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

- 1. This Bylaw may be cited as BURNABY LOCAL IMPROVEMENT CONSTRUCTION BYLAW NO. 7, 1997.
- 2. The Council of the City of Burnaby is hereby authorized and empowered to construct as a local improvement under the provisions of Part 19 of the Municipal Act all necessary equipment, wires, and works, including standards and underground conduits, for the purpose of supplying public lighting for the following streets:
 - (a) Aubrey Street from Cliff Avenue to Sperling Avenue
 - (b) Berwick Street from Waltham Avenue to Gilley Avenue
 - (c) Boxer Street from the end of the cul-de-sac to McKay Avenue
 - (d) Dorset Street from Antrim Avenue to MacPherson Avenue
 - (e) Edmonds Street from 6th Street to 4th Street
 - (f) Elwell Street from Sperling Avenue to Griffiths Avenue
 - (g) Hunter Street from Lakedale Avenue to Hunter Court and Hunter Court from Hunter Street to the northern property line of 3525 Hunter Court
 - (h) McKee Street from the Ravine west of Buller Avenue to Gilley Avenue
 - (i) Napier Street from Kensington Avenue to Sperling Avenue
 - (j) Ellesmere Avenue from Halifax Street to Grant Street

- 3. The Clerk is authorized and empowered to cause a contract for the construction of the said works to be made and entered into with some person or persons, firm or corporation, subject to the approval of Council to be declared by resolution.
- 4. The special charges shall be paid by ten annual instalments.
- 5. The Assessor shall forthwith prepare a frontage tax assessment roll in respect of the said works pursuant to Section 432 of the *Municipal Act* and in accordance with the provisions of Bylaw No. 8417, as amended, and shall from time to time revise the said frontage tax assessment roll in accordance with subsection (3) of the said Section 432.
