

A BYLAW to stop up and close to traffic  
portions of road

WHEREAS those portions of road shown on the plan annexed hereto dedicated by Plans 3036 and 29773 are no longer required for road purposes;

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY ROAD CLOSING BYLAW NO. 1, 1999.**
2. Those portions of road situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being more particularly known and described as those portions of road in District Lot 30, Group 1, New Westminster District, dedicated by the deposit of Plans 3036 and 29773 containing by admeasurement 1345.6 m<sup>2</sup> and 401.2 m<sup>2</sup>, respectively, shown outlined on the plan prepared by E.T. Wong, B.C.L.S., certified correct the 5th day of January, 1999, a copy of which is annexed hereto, is hereby stopped up and closed to traffic.
3. The City Clerk is hereby authorized and empowered to petition the Minister of Municipal Affairs to abandon the said portions of road more particularly described in section 2 hereof and vest title thereto in the name of the City of Burnaby.

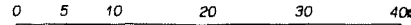

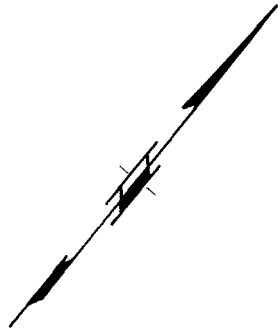

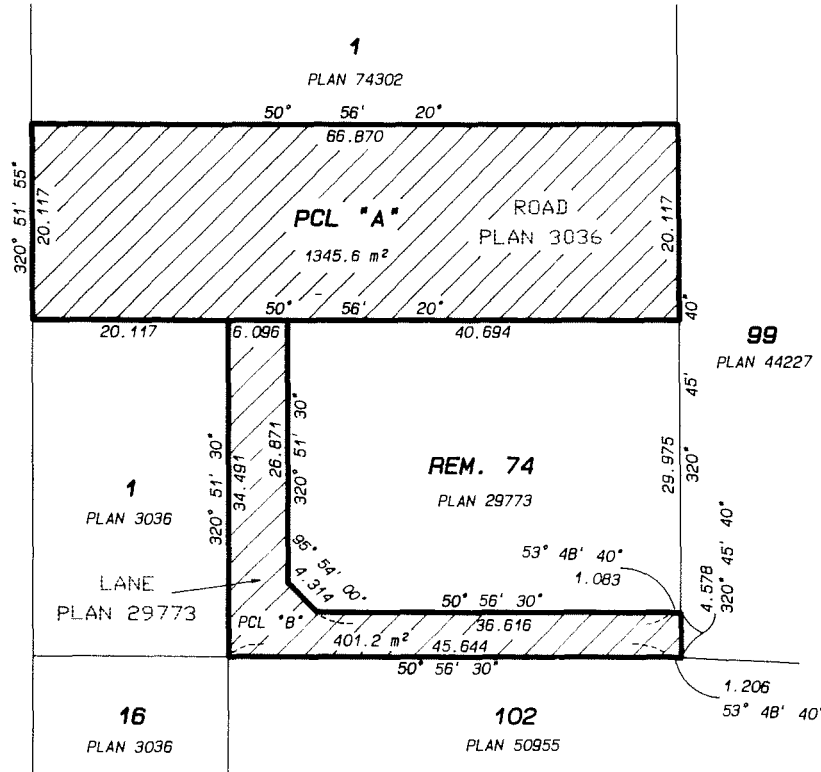
