BYLAW NO. 11001

A BYLAW to dedicate certain lands within the City for public parks at Brunette River Conservation Lands, Burnaby Fraser Foreshore Park, Burnaby Mountain Conservation Area, Capitol Hill Conservation Area, Confederation Park, Deer Lake Park, Kensington Park, Taylor Park/ Fourteenth Avenue Ravine Park

WHEREAS section 308 of the *Municipal Act* empowers Council, with the assent of the electors, to dedicate for a public purpose real property owned by the City;

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY PARK DEDICATION BYLAW 1999.**
2. There is hereby dedicated for park and recreation uses of the public that real property owned by the City and more particularly described in Schedules A to H inclusive.
