- 2. Burnaby Parks, Recreation and Culture Commission may charge for the use of facilities at the Shadbolt Centre for the Arts and Ceperley House the fees specified in Schedule "A".
- 3. Burnaby Shadbolt Centre Rental Fees Bylaw 1999, Bylaw No. 10981, is repealed.
- 4. This Bylaw comes into force on the first day of September, 2000.
