BYLAW NO. 11182

A BYLAW to amend Bylaw No. 4231, being the
Burnaby Sewer Charge Bylaw 1961

The Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY SEWER CHARGE BYLAW 1961, AMENDMENT BYLAW 2000.**
2. Subsections (1) and (1.1) of section 4A of the said Bylaw are repealed and the following substituted therefor:
 - "(1) The user classified hereunder shall pay for the use of the municipal sewerage system the charge hereinafter specified:
 - (a) the owner of any strata lot (not being part of a duplex) shall pay an annual charge of \$147.18 if paid on or before March 15, 2001 or an annual charge of \$154.93 if paid after March 15, 2001;
 - (b) the owner of any multiple-family dwelling (except a duplex) used exclusively for residential purposes shall pay for each apartment unit therein an annual charge of \$147.18 if paid on or before March 15, 2001 or an annual charge of \$154.93 if paid after March 15, 2001; and
 - (c) the owner of an apartment unit forming part of a duplex shall pay an annual charge of \$68.25 if paid on or before March 15, 2001 or an annual charge of \$71.84 if paid after March 15, 2001.
 - (1.1) The charge for a permit to discharge groundwater into the sanitary sewer system from a contaminated site shall be:
 - \$0.211/m³ in the Vancouver Sewerage Area
 - \$0.280/m³ in the Fraser Sewerage Area."

4. Schedules "A" and "B" of the said Bylaw, as enacted by Bylaw No. 11036, are repealed and the following substituted therefor:




