BYLAW NO. 11290

A BYLAW to exempt from taxation certain lands and improvements pursuant to section 341(1) and (2)(n) of the *Local Government Act*

The Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY TAXATION EXEMPTION BYLAW NO. 9, 2001.**
2. Pursuant to section 341(1) and (2)(n) of the *Local Government Act*, Council does hereby exempt from taxation under section 359(1)(a) of the said Act for the year 2002 the interest in a municipal building of a non-profit organization that uses or occupies the building as a licensee or tenant of the City of Burnaby, namely:
 1. Burnaby Heights School - 250 S. Willingdon Avenue (Roll No. 5655-0250) more particularly described as Parcel 1, District Lots 122 and 188, Group 1, New Westminster District, Plan NWP87902, occupied by:
 - (a) Scout Properties (B.C. - Yukon) Ltd.
 - (b) B.C. Amateur Boxing Association
 - (c) Burnaby Family Life Institute
 - (d) Burnaby Information and Community Services Society
 - (e) Burnaby Volunteer Centre Society
 - (f) Royal Canadian Air Cadets
 - (g) Burnaby Seniors Outreach Services Society
 - (h) C.A.S.I. (Comitato Attivita Scolastiche Italiane)
 - (i) Burnaby - New Westminster Childcare Support Program
 - (j) Family as Support Teams Society, The Rainbow Bridge
 - (k) Caireen Child and Family Services Society
 - (l) Carpentry Apprenticeship Board of B.C.
 - (m) Marguerite Dixon Transition Society
 - (n) Lower Mainland Square and Round Dance Building Society
 - (o) Arrows to Freedom Cultural Healing Society

4. Community Space - 7521 Hanna Court (Roll No. 6725-7521) more particularly described as Lot 3, District Lot 171, Group 1, New Westminster District, Plan LMP12096, occupied by: Burnaby Children's Centres Society.

5. Community Space - 4397 Buchanan Street (Roll No. 1230-4397) more particularly described as Lot 2, District Lot 119, Group 1, New Westminster District, Plan LMP43814, occupied by: Lower Mainland Purpose Society for Youth and Families.
