# CITY OF BURNABY 

BYLAW NO. 11315

## A BYLAW to amend Bylaw No. 4231, being the Burnaby Sewer Charge Bylaw 1961

The Council of the City of Burnaby ENACTS as follows:

## 1. This Bylaw may be cited as BURNABY SEWER CHARGE BYLAW 1961, AMENDMENT BYLAW 2001.

2. Subsections (1) and (1.1) of section 4A of the said Bylaw are repealed and the following substituted therefor:
"(1) The user classified hereunder shall pay for the use of the municipal sewerage system the charge hereinafter specified:
(a) the owner of any strata lot (not being part of a duplex) shall pay an annual charge of $\$ 154.55$ if paid on or before March 15,2002 or an annual charge of $\$ 162.68$ if paid after March 15,2002 ;
(b) the owner of any multiple-family dwelling (except a duplex) used exclusively for residential purposes shall pay for each apartment unit therein an annual charge of $\$ 154.55$ if paid on or before March 15,2002 or an annual charge of $\$ 162.68$ if paid after March 15,2002 ; and
(c) the owner of an apartment unit forming part of a duplex shall pay an annual charge of $\$ 71.66$ if paid on or before March 15, 2002 or an annual charge of $\$ 75.43$ if paid after March 15, 2002.
(1.1) The charge for a permit to discharge groundwater into the sanitary sewer system from a contaminated site shall be:
$\$ 0.208 / \mathrm{m}^{3}$ in the Vancouver Sewerage Area
$\$ 0.281 / \mathrm{m}^{3}$ in the Fraser Sewerage Area."
3. Schedules " A " and " B " of the said Bylaw, as enacted by Bylaw No. 11182, are repealed and the following substituted therefor:
