A BYLAW authorizing the expenditure of monies in the Capital Works, Machinery and Equipment Reserve Fund

WHEREAS there is an unappropriated balance in the Capital Works, Machinery and Equipment Reserve Fund (hereinafter called "the said Reserve Fund") established pursuant to Bylaw No. 7256 of \$57,417,648.00 as at the 6th day of March, 2002, calculated as follows:

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY CAPITAL WORKS**, **MACHINERY AND EQUIPMENT RESERVE FUND EXPENDITURE BYLAW NO. 4, 2002.**

2. The sum of \$223,600 is hereby appropriated from the said Reserve Fund to be expended on the following works:

2.	Tennis Courts Repairs and upgrades to existing tennis court facilities at Burnaby Lake and Burnaby Heights	41,600
3.	Taylor Park Geotechnical, engineering and environmental consultant service to assist with development of design plans for new park site	52,000
4.	Playgrounds Replacement and upgrades of existing playgrounds at Lobley park, Variety Park and Cariboo park to ensure facilities meet CSA safety standards	78,000

3. Should any of the said sum of \$223,600 remain unexpended after the expenditures hereby authorized have been made, any unexpended balance shall be returned to the credit of the said Reserve Fund.
