

**CITY OF BURNABY**

**BYLAW NO. 11357**

A BYLAW to provide special voting opportunities for the  
2002 general local election and other voting

WHEREAS section 99 of the *Local Government Act* empowers the Council by bylaw to provide special voting opportunities for the general voting day;

AND WHEREAS the general voting day for the 2002 general local election is November 16, 2002;

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY SPECIAL VOTING OPPORTUNITIES BYLAW 2002.**
2. The following places are hereby established as special voting places on November 16, 2002 for the general local election and other voting during the hours specified:



Any elector who contacts the chief election officer not later than 4:00 p.m. September 24, 2002 and provides the chief election officer with such information as the chief election officer may require is entitled to be registered to vote on the general voting day in a voting division other than the one that the elector would otherwise be required to vote in.
