## CITY OF BURNABY

## **BYLAW NO. 11418**

A BYLAW to dispose of certain portions of highway in exchange for other land

WHEREAS pursuant to section 525 of the *Local Government Act*, R.S.B.C. 1996 the Council may by bylaw dispose of any portion of a highway in exchange for such lands as may be necessary for the purpose of improving, widening, straightening, relocating or diverting a highway;

AND WHEREAS all deeds executed under this section have effect as a Crown grant, free of all rights of way, and all lands taken in exchange for any portion of a highway under this section are public highways, and the title thereto is vested in the Crown;

AND WHEREAS the Council, before adopting this Bylaw, has caused the required statutory public notice of its intention to be given by advertisement;

AND WHEREAS the Council deems it expedient and in the public interest to stop up and close to traffic those portions of highway more particularly hereinafter described for the purpose of relocating and diverting a highway;

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

This Bylaw may be cited as **BURNABY HIGHWAY EXCHANGE BYLAW NO.** 8, 2002.

2. The Council of the City of Burnaby is hereby authorized and empowered to stop up and close to traffic ALL AND SINGULAR those certain parcels or tracts of land, situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, more particularly known and described as all those portions of road in

- (a) District Lot 77, Group 1, New Westminster District, dedicated by Plan 3051, containing 0.763 ha.,
- (b) District Lot 76, Group 1, New Westminster District, dedicated by Plan 1885, containing 0.434 ha.,
- (c) District Lot 75, Group 1, New Westminster District, dedicated by Plan 4147, containing 47 m<sup>2</sup>,
- (d) District Lot 76, Group 1, New Westminster District, dedicated by Plan LMP22853, containing 465 m<sup>2</sup>,
- (e) District Lot 76, Group 1, New Westminster District, dedicated by Plan LMP22853, containing 0.117 ha.,
- (f) District Lot 76, Group 1, New Westminster District, dedicated by Plan 1885, containing 20 m<sup>2</sup>,
- (g) District Lot 77, Group 1, New Westminster District, dedicated by Plan 3051, containing 0.228 ha.,
- (h) District Lot 77, Group 1, New Westminster District, dedicated by Plan 13680, containing 92 m<sup>2</sup>,
- (i) District Lot 77, Group 1, New Westminster District, dedicated by Plan 13354, containing 92 m<sup>2</sup>, and
- (j) District Lot 77, Group 1, New Westminster District, dedicated by Explanatory Plan 14346 containing 144 m<sup>2</sup>

(hereinafter called "the said closed portions of road") and shown hatched on Reference Plan prepared by G.N. Holme, B.C.L.S., deposited in the Land Title Office under Number LMP\_\_\_\_\_, a copy of which is hereunto annexed (hereinafter called "the said plan").

3. The Council is further authorized and empowered to grant and convey the said closed portions of road unto the registered owner of Parcel Identifier 023-058-641, Lot 3, Blocks 6 and 7, District Lot 76, Group 1, New Westminster District, Plan LMP22853 (hereinafter called "the said lot") in exchange for that portion of the said lot containing 239 m<sup>2</sup>, shown outlined on the said plan, and that portion of the said lot shall, upon deposit of the necessary transfer in the Land Title Office, be public highway and title thereto shall be vested in the Crown.

Burnaby Highway Exchange Bylaw No. 9, 1999, Bylaw No. 10992 is repealed.
