A BYLAW to dedicate certain lands within the City for public parks at Cameron Park, Deer Lake Park, Eagle Creek Ravine Park, Froggers Creek Ravine Park, Gray Creek Ravine Park, John Matthews Creek Ravine Park, Lubbock's Woods Park, Montrose Park, Taylor Park

WHEREAS section 303 of the *Local Government Act* empowers Council, with the assent of the electors, to dedicate for a public purpose real property owned by the City;

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

- 1. This Bylaw may be cited as **BURNABY PARK DEDICATION BYLAW 2002.**
- 2. There is hereby dedicated for park and recreation uses of the public that real property owned by the City and more particularly described in Schedules A to I inclusive.
