## **CITY OF BURNABY**

#### **BYLAW NO. 12338**

A BYLAW to exempt from taxation certain lands and improvements pursuant to section 224(1) and (2)(c) of the *Community Charter* 

WHEREAS in the opinion of Council certain lands and improvements would qualify for exemption from taxation but for a secondary use;

AND WHEREAS such secondary use consists of the use of a portion of the land and improvements for commercial purposes;

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

- 1. This Bylaw may be cited as **BURNABY TAXATION EXEMPTION BYLAW** NO. 7, 2007.
- 2. Pursuant to sections 224(1) and (2)(c) of the *Community Charter*, Council does hereby for the year 2008 exempt from taxation under section 197(1)(a) of the said Act, the following lands and improvements, namely:

## **BURNABY PACIFIC GRACE CHURCH**

3883 Triumph Street Roll No. 0560-3883

That portion of land occupied by the Burnaby Pacific Grace Chinese Church, described as follows:


