BYLAW NO. 12883

A BYLAW to amend Bylaw No. 4231, being the
Burnaby Sewer Charge Bylaw 1961

The Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY SEWER CHARGE BYLAW 1961, AMENDMENT BYLAW 2010.**

2. Subsections (1) and (1.1) of section 4A of the said Bylaw are repealed and the following substituted therefore:

"(1) The user classified hereunder shall pay for the use of the municipal sewerage system the charge hereinafter specified:

- (a) the owner of any strata lot (not being part of a duplex) shall pay an annual charge of \$234.29 if paid on or before March 15, 2011 or an annual charge of \$246.62 if paid after March 15, 2011;
- (b) the owner of any multiple-family dwelling (except a duplex) used exclusively for residential purposes shall pay for each apartment unit therein an annual charge of \$234.29 if paid on or before March 15, 2011 or an annual charge of \$246.62 if paid after March 15, 2011; and
- (c) the owner of an apartment unit forming part of a duplex shall pay an annual charge of \$108.62 if paid on or before March 15, 2011 or an annual charge of

\$114.34 if paid after March 15, 2011.

(1.1) The charge for a permit to discharge groundwater into the sanitary sewer system from a contaminated site shall be:

\$0.270/m³ in the Vancouver Sewerage Area

\$0.324/m³ in the Fraser Sewerage Area."

3. Schedules "A" and "B" of the said Bylaw are repealed and the following substituted therefor:


4. This Bylaw shall come into force on the 1st day of January, 2011.
