BYLAW NO. 13030

A BYLAW to amend Bylaw No. 4231, being the
Burnaby Sewer Charge Bylaw 1961

The Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY SEWER CHARGE BYLAW 1961, AMENDMENT BYLAW NO. 2, 2011.**

2. Subsections (1) and (1.1) of section 4A of the said Bylaw are repealed and the following substituted therefore:

"(1) The user classified hereunder shall pay for the use of the municipal sewerage system the charge hereinafter specified:

(a) the owner of any strata lot (not being part of a duplex) shall pay an annual charge of \$248.35 if paid on or before March 15, 2012 or an annual charge of \$261.42 if paid after March 15, 2012;

(b) the owner of any multiple-family dwelling (except a duplex) used exclusively for residential purposes shall pay for each apartment unit therein an annual charge of \$248.35 if paid on or before March 15, 2012 or an annual charge of \$261.42 if paid after March 15, 2012; and

(c) the owner of an apartment unit forming part of a duplex shall pay an annual charge of \$115.14 if paid on or before March 15, 2012 or an annual charge of \$121.20 if paid after March 15, 2012.

- (1.1) The charge for a permit to discharge groundwater into the sanitary sewer system from a contaminated site shall be:

\$0.289/m³ in the Vancouver Sewerage Area

\$0.351/m³ in the Fraser Sewerage Area."
