## **BYLAW NO. 13360**

## A BYLAW to provide special voting opportunities for the 2014 general local election and other voting

WHEREAS section 99 of the Local Government Act empowers the Council by bylaw to provide special voting opportunities for the general voting day;

AND WHEREAS the general voting day for the 2014 general local election is November 15, 2014;

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY SPECIAL VOTING OPPORTUNITIES BYLAW 2014.**
