**BYLAW NO. 13935**

A BYLAW to amend the  
Planning and Building Fees

The Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY PLANNING AND BUILDING FEES BYLAW 2017, AMENDMENT BYLAW NO. 1, 2018**
  
2. Burnaby Planning and Building Fees Bylaw 2017, is amended by:
  - (a) at Section 2, by deleting it in its entirety and replacing it with the following:
