BYLAW NO. 13975

A BYLAW to designate the Schou Street School at
4041 Canada Way a protected heritage property

WHEREAS the Schou Street School (hereinafter referred to as the “Heritage Building”) is located at 4041 Canada Way, and more particularly legally described as:

AND WHEREAS the registered owner of the Lands has requested that Council designate the Heritage Building as protected heritage property;

AND WHEREAS Council considers the Heritage Building has heritage value and heritage character, and that designation of the building pursuant to section 611 of the *Local Government Act* is necessary or desirable for its conservation;

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY HERITAGE DESIGNATION BYLAW NO. 3, 2018.**

2. Council hereby designates the Heritage Building as protected heritage property under section 611 of the *Local Government Act*.
