

**CITY OF BURNABY**

**BYLAW NO. 14017**

A BYLAW to close and remove the dedication of  
a certain portion of highway

WHEREAS pursuant to section 40 of the *Community Charter* and section 120 of the *Land Title Act* the Council may by bylaw close part of a highway to traffic and remove the dedication of that part of the highway;

AND WHEREAS the Council, before adopting this Bylaw, has caused the required statutory public notice of its intention to be given by advertisement;

AND WHEREAS the Council deems it expedient and in the public interest to stop up and close to traffic and remove the dedication of that portion of highway more particularly hereinafter described;

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY HIGHWAY CLOSURE BYLAW NO. 1, 2019.**
2. ALL AND SINGULAR that certain parcel or tract of land, situate, lying and being in the City of Burnaby, in the Province of British Columbia, more particularly known and described as all those portions of road in District Lot 119, Group 1, New Westminster District:
  - (a) road dedicated by Plan 2855 containing 612.8m<sup>2</sup>; and
  - (b) road dedicated by Plan 40447 containing 112.1m<sup>2</sup>.

(hereinafter called "the closed portion of road") shown outlined on Reference Plan prepared by Patrick Korabek, B.C.L.S., and certified in the Land Title Office under Number EPP92155, a copy of which is hereunto annexed is hereby closed to all types of traffic.

3. The dedications of the closed portion of road as highway are removed.

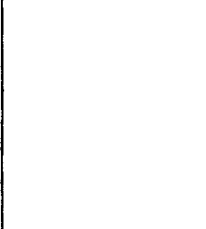
