A BYLAW to amend the
Engineering Fees Bylaw

The Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY ENGINEERING FEES BYLAW 2018, AMENDMENT BYLAW NO. 1, 2021.**
2. Burnaby Engineering Fees Bylaw 2018, as amended, is further amended by deleting Schedules A to H in their entirety and replacing them with the schedules attached to and forming part of this Bylaw.
3. This Bylaw shall come into force and effect on January 1, 2022.


