(b) at Schedule "A", under the heading, "Administration of Servicing Requirements File",by deleting the first sentence in its entirety and replacing it with the following:

"For a Rezoning or Preliminary Plan Approval application that does not include a Subdivision application, or a Temporary Use Permit application; or"

 (c) after Schedule D, by adding "Schedule D-1 Temporary Use Permit (TUP) Application", attached to this Bylaw.
