

**CITY OF BURNABY**

**BYLAW NO. 14453**

A BYLAW to close and remove the dedication of  
certain portions of highway

WHEREAS pursuant to section 40 of the *Community Charter* and section 120 of the *Land Title Act* the Council may by bylaw close part of a highway to traffic and remove the dedication of that part of the highway;

AND WHEREAS the Council, before adopting this Bylaw, has caused the required statutory public notice of its intention to be given by advertisement;

AND WHEREAS the Council deems it expedient and in the public interest to stop up and close to traffic and remove the dedication of those portions of highway more particularly hereinafter described;

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY HIGHWAY CLOSURE BYLAW NO. 2, 2022.**
  
2. ALL AND SINGULAR those certain parcels or tracts of land, situate, lying and being in the City of Burnaby, in the Province of British Columbia, more particularly known and described as those portions of road dedicated in District Lot 155A and District Lot 171, Group 1, New Westminster District:
  - (a) by Plan 1425 identified as “Parcel A” and containing 0.259ha;
  
  - (b) by Plan 24105 identified as “Parcel B” and containing 181.2m<sup>2</sup>;
  
  - (c) by Plan 14019 identified as “Parcel C” and containing 543.6m<sup>2</sup>;

(d) by Plan 1425 identified as “Parcel D” and containing 0.272ha; and

(e) by Plan 992 identified as “Parcel E” and containing 750.5m<sup>2</sup>

all as shown outlined in bold on Reference Plan EPP122271 (hereinafter collectively called “the closed portions of road”), prepared by G.A. Rowbotham, B.C.L.S., a copy of which is hereunto annexed, are hereby closed to all types of traffic.

3. The dedications of those closed portions of road as highway are removed.



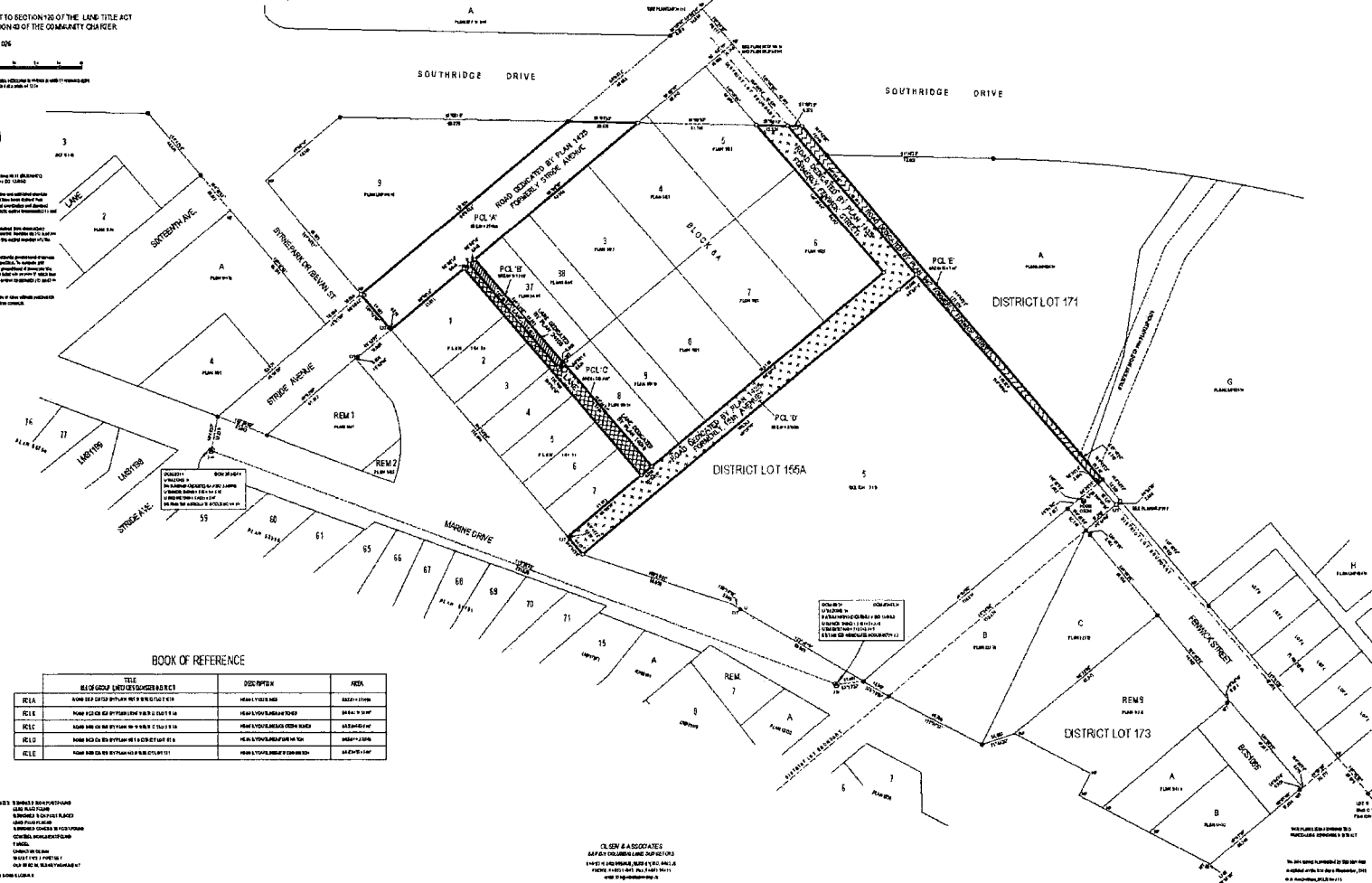
