

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 2011

A BY-LAW to amend By-law No. 1949

THE COUNCIL of the Corporation of the District of Burnaby ENACTS as follows:-

1. "Burnaby Incinerator and Garbage Disposal By-law 1947" being By-law No. 1949 of the Corporation is hereby amended by numbering the first paragraph of "Zone A", Schedule "A" as (1) and by adding to said "Zone A" the following as paragraph (2):-

(2) Commencing at the intersection of Myrtle Street and Boundary Road, thence easterly along Myrtle to Smith Avenue, thence south along Smith Avenue to the Myrtle-Regent Lane, thence easterly along the Myrtle-Regent Lane to Ardley Avenue, thence south along Ardley Avenue to the Grandview Highway, thence west along the Grandview Highway to Crown Avenue, thence south along the Boundary between D.L. 68 and D.L. 71 to Spruce Street, thence east along Spruce Street to Halley Avenue, thence south along Halley Avenue to Fir Street, thence east along Fir Street to Huxley Avenue, thence south on Huxley Avenue to Moscrop Street, thence east along Moscrop Street to Willingdon Avenue, thence south along Willingdon Avenue to Grassmere Sgreet, thence east along Grassmere Street to Royal Oak Avenue, thence south on Royal Oak Avenue to Milton Street, thence east along Milton Street to Hazard Street, thence northeast along Hazard Street to Sperling Avenue, thence north along Sperling Avenue to Douglas Road, thence northwest along Douglas-Grandview Highway to Westminster Avenue, thence north along Westminster Avenue to Regent Street, thence east along Regent Street to Douglas Road, thence south along Douglas Road to Laurel Street, thence east along Laurel Street to the B.C.E.R. Burnaby Lake Line, thence woutheast and east along the Burnaby Lake Line to 4th Street, thence southeast along 4th Street to Wedgewood Avenue, thence northeast along Wedgewood Avenue to Second Street, thence southeast along Second Street to 18th Avenue, thence northeast along 18th Avenue to 1st Street,

thence southeast along 1st Street to 16th Avenue, thence northeast along 16th Avenue to Cumberland Street, thence southeast along Cumberland Street to Armstrong Avenue, thence northeast along Armstrong Avenue to Caribou Road, thence southeast along Caribou Road to 10th Avenue, thence southwest along 10th Avenue to 15th Street, thence northwest along 15th Street to Stride Avenue, thence southwest along Stride Avenue to the B.C.E.R. Central Park Line, thence north and west along the Central Park Line to Gilley Avenue, thence south and southwest along Gilley Avenue to Marine Drive, thence west along Marine Drive to Boundary Road, thence north along Boundary Road to Myrtle Street, being the point of commencement.

2. "Burnaby Incinerator and Garbage Disposal By-law 1947" being By-law No. 1949 of the Corporation is hereby further amended by numbering the first paragraph of "Zone B", Schedule "A" as (1) and by adding to said "Zone B" the following as paragraph (2):-

(2) Commencing at the intersection of Edinburgh Street and Boundary Road, thence east along Edinburgh Street to Carlton Avenue, thence south along Carlton Avenue to Yale Street, thence east along Yale Street to Madison Avenue, thence south along Madison Avenue to McGill Street, thence east along McGill Street to Willingdon Avenue, thence south along Willingdon Avenue to the Albert-Pandora Lane, thence east along the Albert-Pandora Lane to Delta Avenue, thence north along Delta Avenue to Cambridge Street, thence east along Cambridge Street to Hythe Avenue, thence north along Hythe Avenue to the lane south of Bessborough Drive, thence north and east along the lane south of Bessborough Drive and Shannon Street to Highfield Road, thence southeast along Highfield Road to Cambridge Street, thence east along Cambridge Street to the lane east of Fell Avenue, thence south along the lane east of Fell Avenue and the prolongation of said lane to Hastings Street, thence west along Hastings Street to Holdom Avenue, thence south along Holdom Avenue to Union Street, thence west along Union Street to Willingdon Avenue, thence south along Willingdon Avenue to the Central Arterial Highway, thence

west along the Central Arterial Highway and Douglas Road to Halifax Street, thence west along Halifax Street and the lane south of Halifax Street to Boundary Road, thence north along Boundary Road to Edinburgh Street being the point of commencement.

3. This By-law may be cited as "BURNABY INCINERATOR AND GARBAGE DISPOSAL BY-LAW 1947, AMENDMENT BY-LAW 1948."
