

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 2019.

A BY-LAW to authorize the expenditure of certain monies set aside for the purpose of constructing water mains, renewals, extensions and hydrants, in the Municipality of Burnaby.

WHEREAS by By-law No. 1837, The Corporation of the District of Burnaby set aside the sum of \$175,000.00 in trust for the specific purpose of constructing waterworks mains, renewals, extensions and hydrants:

AND WHEREAS by By-law No. 1885, the said By-law No. 1837 was amended by adding after the word "purposes" in the seventh line of Section 1 the words "and to purchase the necessary machinery, equipment and tools for carrying out the said work".

AND WHEREAS by By-law No. 1886, approved by Order-in-Council No. 1743, dated the 9th day of October, 1945, the Corporation authorized the expenditure of the sum of \$169,950.00

AND WHEREAS there remains in the said fund set aside by By-law No. 1837, the sum of \$5,050.00 together with accrued interest.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:-

1. The sum of \$5,050.00 together with accrued interest thereon set aside by By-law No. 1837 of the Corporation, is hereby appropriated for the purpose of constructing water mains, renewals, extensions and hydrants, within the Municipality of Burnaby.

2. The monies hereby appropriated shall be expended by the Corporation upon resolution of the Council, and the Reeve and Clerk are hereby empowered to do all necessary acts and things to give effect to the transfer and use of the funds hereby appropriated.

3. This By-law may be cited as "BURNABY WATERWORKS RESERVE FUND EXPENDITURE BY-LAW 1948".

DONE AND PASSED in Open Council this Twelfth (12th) day of July, A.D. 1948.

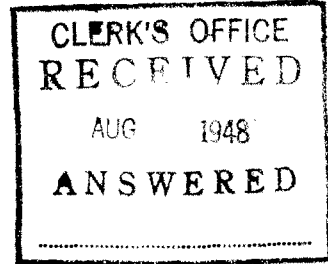

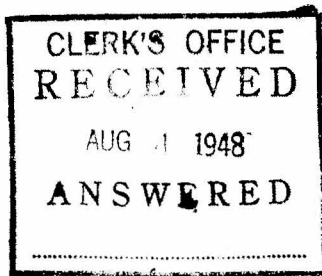
