A BY-LAW to authorize the sale of Lot 53, of subdivision of Lots Thirty One (31), Thirty two (32) and Thirty three (33) of Blocks One (1) and Three (3) of Lot Ninety five (95) Group One (1) New Westminster District, Province of British Columbia, to Francis Joseph Knight.

WHEREAS Lot 53, S.D. 31 to 33, Blocks 1 & 3, D.L. 95. Group

1. New Westminster District, Map No. 1915, was acquired by the

Corporation of the District of Burnaby in the year 1925 for

Corporate purposes.

AND WHEREAS the said lands and premises are no longer required for Corporate purposes.

AND WHEREAS under the provisions of Section 43 of the "District of Burnaby Debt Refunding Act, 1940" permission has been received from the Minister of Municipal Affairs for the Corporation to dispose of the said lot for the sum of \$310.00

AND WHEREAS Francis Joseph Knight of 1523 16th Avenue, in the Municipality of Burnaby, Province of British Columbia, has offered to purchase the said property for the sum of Three hundred and ten (\$310.00) dollars.

AND WHEREAS it is deemed expedient to accept the said offer.

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:-

1. That Lot Fifty three (53) of Lots Thirty one (31),
Thirty two (32) and Thirty three(33) of Blocks One (1) and Three
(3) of District Lot Ninety five (95) Group One (1) New Westminster
District, Map No. 1915. be sold and disposed of to Francis Joseph
Knight, of 1523 - 16th Avenue, in the Municipality of Burnaby,
Province of British Columbia for the sum of Three hundred and
ten (\$310.00) dollars, and that upon payment of the said sum to
The Corporation of the District of Burnaby that the Reeve and
Clerk be authorized to execute and set the Corporate seal to an
Indenture of Conveyance to the said Francis Joseph Knight.

- 2. This By-law shall take effect upon the registration thereof.
- 3. This By-law may be eited for all purposes as "Burnaby Corporate Land Sale By-law No. 4. 1948."
