THE CORPORATION OF THE DISTRICT OF BURNABY BY-LAW NO. 2045.

A BY-LAW to amend By-law No. 1886 of the Corporation of the District of Burnaby

WHEREAS the Council of The Corporation of the District of Burnaby has by By-law No. 1886, appropriated the sum of \$169,950.00 for the construction, renewal and extension of certain water mains (including hydrant provision) and for the purchase of necessary machinery, equipment and tools for the said construction

AND WHEREAS the said By-law in paragraph (1) thereof enumerated a schedule of streets upon which water mains would be laid.

AND WHEREAS since the date of passing said By-law, being the twenty sixth day of Septemberg 1945, due to resubdivision of property and other reasons, it is no longer necessery that certain of the works provided for be carried out, namely:

By-law No. 1886, with the exception of the works referred to in the preceding recital have been completed at a cost of \$125,550.00

AND WHEREAS due to the elimination of the aforesaid works there is a balance outstanding in the appropriation set up by By-law No. 1886 amounting to \$36,029.83

AND WHEREAS the Council of The Corporation of the District of Burnaby deem it expedient and in the public interest that this sum of \$36,029.83 should be expended for other waterworks projects within the Municipality. AND WHEREAS the Council has caused to be prepared and estimate of the works proposed to be carried out with the aforementioned funds, as follows:

1. The sum of \$36,029.83, being part of the monies appropriated under authority of By-law No. 1886 of The Corporation be hereby appropriated for the purpose of constructing water mains on the streets as set out in the seventh recital to this By-law.

2. The Reeve and Clerk of the Corporation are hereby empowered to do all necessary acts and things to give effect to the use of the funds hereby authorised.

3. This By-law shall come into force and effect upon refeiving the approval of the Lieutenant-Governor in Council.

4. This By-law may be cited as the "BURNABY WATERWORKS RESERVE FUND EXPENDITURE BY-LAW 1945 AMENDMENT BY-LAW 1948."
