

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 2048.

A BY-LAW to authorize the sale of certain Tax Sale Lands belonging to the Corporation of the District of Burnaby, and to accept in part or full payment therefor, other lands in the Municipality.

WHEREAS The Corporation of the District of Burnaby has acquired under Tax Sale proceedings, lands and premises described as Lot Thirty-five (35) of Block Three (3) of District Lot Thirteen (13), Group One (1), New Westminster District, Map No. 3046.

AND WHEREAS John Graham and Laura Mary Graham, of the Municipality of Burnaby, Province of British Columbia, are the owners of lands and premises described as Lot Thirty-two (32) of Block Three (3) of District Lot Thirteen (13), Group One (1), New Westminster District, Map No. 3046.

AND WHEREAS the said John Graham and Laura Mary Graham have requested the Corporation to convey to them the said lands described as Lot Thirty-five (35) of Block Three (3) of District Lot Thirteen (13), Group One (1), New Westminster District, Map No. 3046 and to accept in payment therefor conveyance of the said Lot Thirty-two (32) of Block Three (3) of District Lot Thirteen (13), Group One, (1), New Westminster District, Map No. 3046, together with the sum of Twenty (\$20.00) dollars.

AND WHEREAS it is deemed advisable to effect such exchange of lands and premises.

THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:-

1. Upon the execution and delivery to The Corporation of the District of Burnaby by John Graham and Laura Mary Graham of a good and sufficient deed of the lands and premises described as Lot Thirty-two (32) of Block Three (3) of District Lot Thirteen (13), Group One (1), New Westminster District, Map No. 3046, free and clear of all encumbrance whatsoever,

together with the sum of Twenty (\$20.00) Dollars, the Reeve and the Clerk are hereby authorized and empowered to execute and set the official and Corporate Seal of The Corporation of the District of Burnaby to a Conveyance of lands and premises described as Lot Thirty-five (35) of Block Three (3) of District Lot Thirteen (13), Group One (1), New Westminster District, Map No. 3046 to the said John Graham and Laura Mary Graham, and to deliver such Conveyance when so executed to the said John Graham and Laura Mary Graham.

2. This By-law may be cited as "BURNABY PROPERTY EXCHANGE BY-LAW NO. 1, 1948."
