BY-LAW NO. 2051

A BY-LAW to authorize the Corporation of the District of Burnaby to acquire certain property within the Municipality and to dedicate the same for highway purposes.

WHEREAS Kelly, Douglas & Company, Limited is the owner of certain lands and premises situate lying and being in the Municipality of Burnaby, Province of British Columbia, more particularly known and described as Part Two hundred and Ninety five one thousandths (0.295) of an acre more or less of Lot "E" of part of Blocks Sixteen (16), Seventeen (17), Eighteen (18) and Nineteen (19) of Lot One hundred and fifty three (153) Group One (1), Map No. 9394, as shown outlined Red on Sketch 11158, New Westminster District.

AND WHEREAS the said Kelly, Douglas & Company, Limited has offered to convey the said lands to the Corporation of the District of Burnaby for the purpose of widening Sussex Avenue in the said Municipality for the nominal sum of One (\$1.00)

AND WHEREAS the Council of The Corporation of the District of Burnaby deems it advisable to accept the said offer.

THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:-

1. It shall be lawful and the Corporation is hereby authorized to accept from Kelly, Douglas & Company, Limited, a conveyance of the lands and premises described as ALL AND SINGULAR that certain parcel or tract of land and premises, situate, lying and being in the Municipality of Burnaby and Province of British Columbia, and more particularly known and described as:-

Part (two hundred and ninety-five one thousandths (0.295) of an acre more or less) of Lot "E" of part of Blocks Sixteen (16), Seventeen (17), Eighteen (18) and Nineteen (19), of Lot One hundred and fifty three (153), Group One (1), Map 9394 as shown outlined Red on Sketch 11158, New Westminster District

free and clear of all encumbrance, for highway purposes.
2. That upon delivery to the Corporation of a good and
sufficient deed of the aforementioned lands free and clear of

all encumbrance the said Kelly, Douglas & Company, Limited shall be paid the sum of One (\$1.00) dollar.

3. That upon registration of the said conveyance, the lands and premises thereby conveyed shall be deemed to be and are hereby dedicated as a highway to and for the free use of the public for all time thereafter.

4. This By-law may be cited for all purposes as "BURNABY LAND ACQUISITION AND STREET DEDICATION BY-LAW (Sussex Avenue) NO. 5, 1948."
