

THE CORPORATION OF THE DISTRICT OF BURNABY.

BY-LAW NO. 2061

A BY-LAW to authorize The Corporation of the District of Burnaby to acquire the North 20 feet of Lots 13, 14, and 15, Block 10, D. L. 121, Group 1, N.W. D. Map No. 1054, and to dedicate the same for highway purposes.

WHEREAS David Robert Whitlock, of 4270 East Hastings Street in the Municipality of Burnaby is the owner of land and premises described as Lot Thirteen (13) of Block Ten (10) of District Lot One hundred and twenty one (121) Group One (1) New Westminster District, Map No. 1054 and has signified his willingness to convey the North twenty (20) feet thereof to The Corporation of the District of Burnaby for highway purposes, free and clear of all encumbrances.

AND WHEREAS Margaret Ann Slavin of 3784 Dundas Street, in the Municipality of Burnaby is the owner of land and premises described as Lots Fourteen (14) and Fifteen (15) of Block Ten (10) of District Lot One hundred and twenty one (121) Group One (1) New Westminster District, Map No. 1054 and has signified her willingness to convey the North twenty (20) feet thereof to The Corporation of the District of Burnaby for highway purposes, free and clear of all encumbrances.

AND WHEREAS The Corporation is desirous of accepting a conveyance or other form of transfer from the said David Robert Whitlock and the said Margaret Ann Slavin respectively of the northerly twenty (20) feet of the lands owned by them.

THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. It shall be lawful for the Corporation and the Corporation is hereby authorized to accept from the said David Robert Whitlock, a conveyance of the North twenty (20) feet of Lot Thirteen (13) of Block Ten (10) of District Lot One hundred and twenty one (121) Group One (1) New Westminster District Map No. 1054 free and clear of all encumbrances.

2. It shall be lawful for the Corporation and the Corporation is hereby authorized to accept from the said Margaret Ann Slavin a conveyance of the North twenty (20) feet of Lots Fourteen (14) and Fifteen (15) of Block Ten (10) of District Lot One hundred and twenty one (121) Group One (1) New Westminster District, Map No. 1054, free and clear of all encumbrances.

3. That upon receipt of the said Conveyances from the said David Robert Whitlock and the said Margaret Ann Slavin, free and clear of all encumbrance the said David Robert Whitlock shall be paid the sum of One thousand five hundred (\$1,500.00) dollars, and the said Margaret Ann Slavin, shall be paid the sum of One (\$1.00) dollar.

4. The Council of The Corporation of the District of Burnaby hereby further enacts that the said north twenty feet of Lots Thirteen (13), Fourteen (14) and Fifteen (15) of Block Ten (10) of District Lot One hundred and twenty one (121) Group One (1) New Westminster District, Map No. 1054, when acquired by the said Corporation shall be and are hereby dedicated as a highway to and for the free use of the public in all time hereinafter.

5. This By-law may be cited for all purposes as "BURNABY LAND ACQUISITION AND STREET DEDICATION BY-LAW NO. 1, 1949."
