

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 2064

A BY-LAW to authorize The Corporation of the District of Burnaby to grant an Easement to The British Columbia Electric Company Limited.

WHEREAS The British Columbia Electric Company Limited is desirous of obtaining an easement or right of way over certain lands belonging to The Corporation of the District of Burnaby for the purpose of constructing, erecting, stringing wires, operating and maintaining towers and poles with guy wires, brackets, cross arms, insulators, transformers, anchors and their several attachments and one or more lines of wire for the transmission and distribution of electrical energy and for telephone purposes.

AND WHEREAS The Corporation of the District of Burnaby is the owner in fee of the lands hereinafter mentioned over which the said easement or right of way is required.

AND WHEREAS under provisions of sub-section 175 of Section 54, of the Municipal Act, the Municipal Council is authorized to make and pass a By-law to dispose of lands.

AND WHEREAS The Corporation of the District of Burnaby are desirous of granting the said easement or right of way to the said British Columbia Electric Company Limited.

THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. It shall be lawful for the Municipal Council of The Corporation of the District of Burnaby to grant unto The British Columbia Electric Company Limited of 425 Carrall Street, in the City of Vancouver, Province of British Columbia, its successors and assigns, full and free right and liberty to enter upon and construct, erect, string, operate and maintain towers and poles with guy wires, brackets, cross arms, insulators transformers, anchors and their several attachments and one or more lines of wire for the transmission and distribution of electrical energy and for telephone purposes upon

(a) ALL AND SINGULAR that certain parcel or tract of land and premises, situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and more particularly known and described as the Easterly thirty (30) feet of Lot One (1), in Block Three (3), District Lot Fifty-six (56), Group One (1), New Westminster District,

Plan No. 4038.

(b) ALL AND SINGULAR that those certain parcels or tracts of land and premises, situate, lying and being in The Municipality of Burnaby, in the Province of British Columbia, and more particularly known and described as set forth in the schedule attached to and forming part of this By-Law, the said portions being more particularly as shown outlined in red on right of way plans deposited in the Land Registry Office at New Westminster, British Columbia under numbers 10363, 10438, and 10599

2. That upon payment to The Corporation of the sum of One thousand, one hundred twenty-nine dollars and fifty cents (\$1,129.50), being the consideration herein, a grant of easement be executed by the Reeve and the Clerk, under the seal of The Corporation and be delivered to The British Columbia Electric Company Limited

3. This By-Law may be cited as "BRITISH COLUMBIA ELECTRIC COMPANY LIMITED EASEMENT BY-LAW 1949."

DONE AND PASSED in Open Council this Twenty-eighth (28th) day of February, A. D. 1949.

RECONSIDERED AND FINALLY PASSED by a three-fourths majority of the Municipal Council, this seventh (7th) day of March, A. D. 1949.
