

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3028

A BY-LAW to authorise the sale of certain Tax Sale Lands belonging to the Corporation of the District of Burnaby, and to accept in part or full payment therefor other lands in the Municipality.

WHEREAS the Corporation of the District of Burnaby has acquired under Tax Sale proceedings, land and premises described as Lot Twenty-one (21) of Block Thirty-three (33) District Lot One Hundred Twenty-two (122), Group One (1), New Westminster District, Map No. 11252.

AND WHEREAS Lawrence Howard Robson, of Bindloss in the Province of Alberta is the owner of lands and premises described as Lots Twenty-two (22) and Twenty-three (23) of Block One (1) District Lot Thirty-nine East (39 E.), Group One (1), New Westminster District, Map No. 1044.

AND WHEREAS the said Lawrence Howard Robson has requested the Corporation to convey to him the said lands described as Lot Twenty-one (21) of Block Thirty-three (33) District Lot One Hundred Twenty-two (122), Group One (1), New Westminster District, Map No. 11252, and to accept in full payment therefor conveyance of the lands and premises described as Lots Twenty-two (22) and Twenty-three (23) of Block One (1) District Lot Thirty-nine East (39 E.), Group One, (1), New Westminster District, Map No. 1044.

AND WHEREAS the Council for the Corporation of Burnaby deems it expedient to effect such exchange of lands.

THE COUNCIL for the Corporation of the District of Burnaby therefore ENACTS as follows:

1. Upon execution and delivery to the Corporation of the District of Burnaby by Lawrence Howard Robson of a good and sufficient deed of the lands and premises described as Lots Twenty-two (22) and Twenty-three (23) of Block One (1) District Lot Thirty-nine East (39 E.), Group One (1), New Westminster District, Map No. 1044, free and clear of all encumbrance whatsoever, the Reeve and Clerk of the Corporation

are hereby authorized and empowered to execute and set the official and Corporate Seal of The Corporation of the District of Burnaby to a Conveyance of lands and premises described as Lot Twenty-one (21) of Block Thirty-three (33) District Lot One Hundred Twenty-two (122), Group One (1), New Westminster District, Map No. 11252 to the said Lawrence Howard Robson, and to deliver such conveyance when so executed to the said Lawrence Howard Robson.

2. This By-law may be cited as "BURNABY PROPERTY EXCHANGE BY-LAW 1949."

DONE AND PASSED on the Twenty-eighth (28th) day of December, A.D. 1949.

RECONSIDERED AND FINALLY PASSED by a three-fourths majority of all the members of the Council this Sixteenth (16th) day of January, A.D. 1950.
