That the obligation or obligations to be given therefor shall be a promissory note or notes signed by the Mayor or Reeve and Finance Committee, and the Clerk of the corporation, and shall bear the corporate seal of the corporation, and shall be for a period within the current year, but may be renewed from time to time as circumstances may require.
5. There is hereby set aside as security for the payment of such money with all interest thereon respectively, the whole of all unpaid taxes assessed and levied by the said corporation, as shown in the Schedule to this By-Law.
