THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3045

A BY-LAW to fix the date the Collector shall add percentage additions to the current year's taxes unpaid on each parcel or land upon the Collector's Roll for the District of Burnapy.

WHEREAS Section 276 or the "Municipal Act" being Chapter 232 of the Revised Statutes of British Columbia 1948 provides as follows:-

"On the first day of July in each year the Collector "shall add to the Current Year's taxes unpaid on each "parcel of land and on the improvements thereon, upon "the Collector's Roll, ten percent of the amount of "the current year's taxes remaining unpaid; and the "said taxes unpaid, together with the amount added. "shall be deemed to be taxes of the current year due "on such land and on the improvements thereon, and the "amount added under this section shall when collected "form part of the general revenue of the Municipality; "provided that the Council may, by By-law passed prior "to the transmission or tax notices in any year under "Section 272, alter the date on which percentage shall "be added, or may direct that part of such percentage "to be added on a certain date and part on some other "date or dates thereafter, put so that the total per-"centage of ten per cent shall be added on unpaid taxes "on the thirty-first day of December of the year in "which the taxes are imposed."

AND WHEREAS it is deemed advisable to alter the date upon which the percentage aforesaid shall be added.

THEREFORE THE COUNCIL or The Corporation of the District of Burnaby ENACTS as follows:-

1. On the Eighteenth (18th) day or July, 1950, the Collector shall add to the current year's taxes unpaid on each parcel of land or improvements upon his roll five (5) per centum or the amount thereof, and upon the Eighteenth (18th) day of August, 1950, shall add an additional amount or one (1) per centum thereof; and on the Eighteenth (18th) day of September, 1950, shall add a rurther additional amount or One (1) per centum thereof; and on the Eighteenth (18th) day of October, 1950, shall add a further additional amount of One (1) per centum thereor; and on the Twentieth (20th) day of November, 1950, shall add a rurther additional amount or One (1) per centum thereor; and on the Eighteenth (18th) day of December, 1950, shall add an additional amount of one (1) per centum thereof; and the said unpaid taxes together with the amount added as aroresaid shall from the respective dates aforesaid be deemed to be the amount of the current year's taxes due upon the said land and improvements.

This By-law may be cited as "BURNABY PERCENTAGE 2. ADDITIONS BY-LAW 1950."

DONE AND FASSED in Open Council the Twenty-fourth (24th) day or April A.D. 1950.

RECONSIDERED AND FINALLY PASSED by the Municipal Council on the First (1st) day or May, A.D. 1950.
