

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3071.

A BY-LAW to authorize The Corporation of the District of Burnaby to acquire certain property within the Municipality of Burnaby and to dedicate the same for highway purposes.

WHEREAS John Goodman, of the Municipality of Burnaby, in the Province of British Columbia, is the owner of land and premises described as Lot One (1) of Block Two (2) of subdivision of the West half of the West half of District Lot One hundred and sixty (160) Group One (1) New Westminster District, Map No. 11224.

AND WHEREAS the said John Goodman has signified his willingness to convey, free from encumbrance, a portion of the said lands and premises to The Corporation of the District of Burnaby (hereinafter referred to as "The Corporation") for highway purposes, all for the sum of One (\$1.00) Dollar.

AND WHEREAS The Corporation is desirous of accepting a conveyance or other form of transfer from the said John Goodman, of the said lands and premises free from encumbrances for the said purpose.

AND WHEREAS the price or value of the said lands and premises does not exceed the sum of Two thousand (\$2,000.00) Dollars.

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:-

1. It shall be lawful for The Corporation and The Corporation is hereby authorized to accept from the said John Goodman a conveyance or other form of transfer of ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Municipality of Burnaby, District of New Westminster and Province of British Columbia, and composed of the Northerly ten (N.10') feet of Lot One (1) of Block Two (2) of subdivision of the West half of the West half of District Lot One hundred and sixty (160) Group One (1) New Westminster District, Map No. 11224.

2. That upon execution and delivery of a conveyance or other form of conveyance by the said John Goodman, free and clear of all encumbrance, to The Corporation of the District of Burnaby, he, the said John Goodman, shall be paid the sum of One (\$1.00) Dollar.

3. That upon registration of the said conveyance or other form of transfer, by The Corporation of the District of Burnaby, the lands and premises conveyed by and described therein shall be deemed to be and are hereby dedicated as a highway to and for the free use of the public in all time thereafter.

4. This By-law may be cited for all purposes as "BURNABY LAND ACQUISITION AND STREET DEDICATION BY-LAW NO. 2, 1950."
