THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3089.

A BY-LAW respecting the granting and the regulating of trades, occupations and businesses in the Municipality of Burnaby.

The Municipal Council of The Corporation of the District of Burnaby, in open meeting assembled, ENACTS as follows:-

1. In the construction and interpretation of this By-law the following words and terms shall have the meanings hereby assigned to them, unless repugnant to the contents hereof or the Municipal Act.

"Applicant" shall mean any person who makes application for any license under the provisions of this By-law.

"Auto Camp" means any area of land on which any building, hut, cabin, trailer, house-car, or other structure is placed and which is used or intended to be used as a temporary residence or habitation for automobile tourists.

"Building Inspector" shall mean the person so appointed from time to time by by-law or resolution of the Council and shall include any acting or assistant Building Inspector.

"Beauty Parlour" means any building, room or place where the business of hairdressing, scalp treatment, manicuring or face treatment for women is carried on.

"Council" shall mean the Municipal Council of The Corporation of the District of Burnaby.

"Chief of Police" shall mean the Chief of Police of The Corporation of the District of Burnaby and shall include any acting or deputy Chief of Police. It shall also include the officer or constable in charge of the Royal Canadian Mounted Police detachment in Burnaby.

"Collector" shall mean the Collector of Taxes for The Corporation of the District of Burnaby.

"Commercial Vehicle" shall mean and include any vehicle required to be licensed by this by-law.

"Dance Hall" means any building, room or place where public or private dances are held or permitted for hire or profit other than those located in a cabaret.

"Dancing Academy" means any building, room or place where dancing is taught for profit.

"Hawker" "Peddler" or "Huckster" shall have the meaning assigned to them by the Municipal Act and amendments thereto.

"Inspector" shall mean the person appointed from time to time by By-law or resolution of the Council as License Inspector of the Municipality and shall include any acting or assistant Inspector or Inspectors.

"Junk" includes any of the following used or old articles or things; rubber, tires, metal, bottles, glass, paper, sacks, wire, ropes, rags, machinery, or any other article or thing commonly found in a junk shop.

"Laundry" means any building, or part thereof, where the business of washing clothing or other fabrics is carried on, and shall include premises where the business of linen supply is carried on.

"Laundry Office" means any building, room or place where the business of distributing laundered clothing, or of collecting clothing to be laundered is carried on apart and separate from the premises where the business of laundering is actually carried on.

"Licence Plate" shall mean the metal plate issued in conjunction with a license for any vehicle licensed under this by-law.

"Manufacturer" shall mean and include any manufacturer, brick-yard, concrete block manufacturer, wholesale bakery, cannery, fish curing plant, fruit processing plant, foundry, machine shop, sawmill, shingle mill, pole mill, tie mill, oil refinery, steel fabricating plant, ship builder, sheet metal works, tinsmith, woodworking shop, and wood fabricating plant when any of the above mentioned businesses employ more than twenty-five persons.

"Medical Health Officer" shall mean the Medical Health Officer duly appointed for the Municipality.

"Person" shall in addition to the ordinary meaning, mean and include a firm or partnership, association, company or corporation and the singular shall be held to mean and include the plural; masculine the feminine and the converse.

"Private Patrol Agency" means every person who by contract or agreement undertakes to watch or patrol the premises of more than one person for the purpose of guarding or protecting persons or property against robbery, theft, burglary, or other hazards.

"Restaurant" means any coffee shop, coffee counter, tea room or any place, whether permanent or temporary, or fixed or movable, in which prepared foods or beverages are served to the public in exchange for money or services, or any place to which the public have access for the purpose of purchasing prepared food or beverages for human consumption on the premises.

"Retail Trader" means every person who sells or offers to sell to any other person by retail any goods, ware, merchandise or other commodity.

"Shooting Gallery" means any building, room or place where the shooting or firing of any gun, rifle, or similar device is permitted for hire or gain, whether the said building, room, or place is devoted exclusively to the shooting of guns, rifles or similar devices or not.

"Transient Trader" shall have the meaning assigned by the Municipal Act and amendments thereto.

"Transient Hairdresser" shall have the meaning assigned by the Municipal Act and amendments thereto.

"Transient Real Estate Agent" shall have the meaning assigned by the Municipal Act and amendments thereto.

"Travel Agency" shall mean any person who acts as agent for any railway, bus, or steamship company.

2. (a) Where the license fee for any business, trade, occupation or calling, licensed under this By-law, is based on the number of persons engaged in the business, the number of chairs, seats, tables, apartments, rooms, or the capacity or accommodation available, or in whatsoever manner the license fee is based; no person shall change the number of persons engaged in the business, the number of chairs, seats, apartments, rooms, the capacity or accommodation available, or any other condition upon which the said license fee is based without first having notified the Inspector in writing and paid any additional license fee which may be payable under this By-law as a result of such change.
- (b) Every license issued under this By-law shall be made out in duplicate. One copy shall be delivered to the person licensed (and the Inspector shall retain the other copy), and such person shall, where possible post the same, and keep the same posted in a conspicuous place on the premises, or on the thing or article in respect of which the license is issued, and anyone failing to post up, and keep same posted as aforesaid, shall be guilty of an infraction of this By-law, and liable to the penalties hereof.
- (c) The Inspector shall furnish, at the cost of the Municipality, to each person taking out a license with respect to the operation of a commercial vehicle a licence plate for each such commercial vehicle with the number of the license painted or stamped thereon, such plate to be the property of the Municipality; and on the cancellation, suspension or revocation of the license corresponding thereto or represented thereby, such person shall forthwith return such license plate to the Inspector.
- (d) Every person who operates a commercial vehicle licensed under this By-law shall keep the license plate issued to him on each commercial vehicle so licensed in a place designated by the Inspector and it shall be unlawful for any person to transfer the license plate to any other vehicle without having first been granted permission by the Inspector.

(e) In case of the loss, mutilation, or destruction of any license plate furnished pursuant to this By-law, upon receipt of a written application accompanied by proof satisfactory to the Inspector of such loss, mutilation or destruction, and if possible the said licence plate, the Inspector may issue a new plate the fee for which shall be one dollar.

(f) The license holder of every commercial vehicle shall cause to be placed on each vehicle, where it may be readily seen, the name and address of the license holder.

3. (a) Every person carrying on, maintaining, owning, or operating within the Municipality any profession, business, trade, occupation, calling, undertaking, or thing, set forth in or covered by Schedule "A" of this By-law, shall hold a subsisting license therefor from the Municipality, and shall pay therefor the fee specified in Schedule "A" in respect thereof, which fee shall in all cases be paid in advance. The words "person engaged in the business" or "persons engaged in the business" when used in said Schedule "A" shall include any person within the Municipality connected with the business in any manner whatsoever, whether as an owner, partner, employe, servant, or agent, or in any other capacity.

(b) Every person who operates more than one distinct store, branch, premises, or place of business in respect of any of the trades, occupations, callings, businesses, or undertakings referred to in this By-law shall take out a separate license in respect of each such separate and distinct store, branch, premises, or place of business.

4. Every licensed Retail Trader who sells or offers for sale any commodity, or carries on any business as a side line subsidiary to and in conjunction with the business for which he already holds a license, shall procure an additional license in respect of each such side line, and shall pay the sum specified therefor in Schedule "A".

5. Every person holding or required to hold a license under the provisions of this by-law shall be subject to the provisions of this by-law, and non-compliance with any of the said provisions shall

be deemed to be an infraction of the same and shall render any person violating or failing to comply with any of the said provisions hereof, liable to the penalties hereby imposed.

6. (a) All applications for licenses under this By-law shall be made to the Inspector on an application form to be provided for that purpose.

(b) Upon receipt of an application, and before issuing any license thereon, the Inspector shall ascertain whether the applicant is a fit and proper person to hold such license; and in the event of the Inspector refusing to issue such license, the applicant shall have the right of appeal to the Council, which shall give the applicant an opportunity of being heard, and thereupon may either grant such license, or refuse the same without giving any reason therefor.

(c) All applications for licenses shall give a description in detail of the premises in or upon which the applicant intends to carry on the business, trades, occupation or calling, in respect of which he has made an application for a license; and no person to whom a license has been granted shall carry on such business, trade, occupation or calling, in or upon any premises other than those set forth in the said application and license without first making an application under this section for a new license, or under the next succeeding section for a transfer of such license.

(d) All premises in or upon which the applicant for a license proposes to carry on or conduct any trade, business, profession, occupation, calling, employment or purpose, subject to the provisions of this By-law, shall, before any such license is granted, first be approved by the Inspector who may, in his discretion, also require such premises or vehicle to be approved by the Medical Health Officer, the Sanitary Inspector, the Building Inspector and/or the Local Fire Prevention Officer, or any other Municipal Official or all or any of them, as the case may be.

(e) Any person making application for a license under the provisions of this By-law shall, at the time of making such application for such license, make a true and correct statement in writing disclosing the nature and character of the business to be carried on by the applicant, the address of such business, the number of per-

sons engaged or occupied in such business, the number of distinctive lines of goods sold or offered for sale, and the seating capacity or number of tables available for the purpose of such business, and any other information which the Inspector may require, and any person failing to do so, or any person guilty of concealing any material fact, which under the provisions of this By-law should be disclosed in said application as thereinbefore set forth, shall be deemed to be guilty of an infraction of this By-law and shall be liable to the penalties hereby imposed.

(f) The applicant shall, at the time of making such application pay to the Municipality the fee specified in Schedule "A" in respect of the license for which application has been made.

7. (a) Any person desiring to obtain a transfer of any license, or part interest in any license, held under this by-law by any other person, shall make an application in every material respect the same as that required to obtain a license as set forth in the last preceding section; and that the powers, conditions, requirements, and procedure therein contained, relating to the granting and refusal of licenses and appeals thereon, shall apply to all such applications.

(b) Any person who shall purchase the interest of or part of the interest of, any person licensed under this by-law in any business, trade, occupation or calling in respect of which a license has been issued under the provisions of this By-law, and shall carry on or continue such business, trade, occupation, or calling, without first having obtained a transfer of license or a new license, shall be guilty of an infraction of this By-law, and shall be liable to the penalties hereby imposed.

(c) No person to whom a license has been granted under this By-law shall change the location of the premises in which he carries on his business, trade, occupation, or calling without first having applied to the Inspector in writing to have his license altered in respect to the location of the premises set out therein; and the powers, conditions, requirements and procedure hereinbefore set out, relating to the granting and

refusal of licenses shall apply to all such applications.

(d) It shall be unlawful for any person licensed under this By-law to transfer, sell, or in any way dispose of his license to any other person without having first notified the Inspector.

(e) The fee payable in respect of any transfer of license from one person to another shall be as set out in Schedule "A" of this By-law.

(f) No license shall be transferred from one person to another more than once during the calendar year.

8. Every license granted under this by-law shall be made out in duplicate, one copy of which shall be delivered to the person licensed and the other copy retained by the Inspector and the license so granted shall be deemed a personal license to the licensee therein named, but in the event of a sale of the business for which such license is issued the Inspector may permit an assignment of the license to the purchaser of the business on an application for transfer in terms of the provisions of this by-law dealing with transfers.
9. Licenses granted under this By-law shall terminate (except in the case of a daily, monthly or three monthly license hereby authorized) on the Fifteenth day of July or the Fifteenth day of January in each year, whichever date shall next succeed the date of issue of same, and no reduction shall be made or rebate allowed on account of any person commencing business at any particular time or ceasing to do business at any particular time.
10. In every case where the trade, occupation, profession or business set out in Schedule "A" hereof is carried on, followed or practised by two or more persons in partnership, it shall be deemed a sufficient compliance with this By-law if one license is taken out in the name of the partnership firm and one license fee paid therefor.
11. The Inspector shall pay to the Collector, for the use of the Municipality, all monies collected by him for licenses issued and shall, within the first ten days of each and every month render to the Council a report showing the number of licenses issued and the total fees collected for the immediate preceding month.



12. (a) It shall be the duty of any person who has been granted a license pursuant to the by-law to carry out the requirements of this by-law and the requirements of any other by-law of the Municipality which may govern or regulate the trade, business, profession, occupation, calling, employment or purpose for which the license has been granted and failure to comply with the requirements of this section shall be grounds for the immediate cancellation, revocation or suspension of the license granted, by the Inspector.
- (b) The suspension, revocation or cancellation of any license shall be made in writing signed by the Inspector and served to the person holding such license or delivered to the holder of such license by registered mail to the address given by the licensee on the application for the license.
- (c) Any person whose licence has been cancelled, suspended or revoked who continues to carry on any trade, business, profession, occupation, calling, employment or purpose for which the license has been granted shall be deemed to have violated the terms of this by-law and be liable to the penalties imposed thereof.
- (d) Any person whose license has been cancelled, suspended or revoked by the Inspector pursuant to the provisions of this by-law, shall have the right of appeal to the Council to be re-instated; and such appeal may be heard at the next regular meeting of the Council to be held after such cancellation, suspension or revocation, as the case may be; and the Council shall make such order, in the premises, amending, varying, reversing, or confirming such cancellation, suspension or revocation, as the case may be, as it may deem expedient and the Council shall not be liable to refund any part of the fee in respect of such premises.
- (e) Notwithstanding anything contained in this by-law, the Council shall have the power to revoke or suspend any license granted in the event of the holder of such license being convicted of an infraction of any law or by-law relating to the trade, business, profession, occupation, calling, employment or purpose in respect of which such license shall have been granted or issued and in such case the Council shall not be liable to refund any part of the fee in respect of such premises. Provided however, that no such license shall be revoked or suspended by the Council unless and until the

party to whom such license is granted shall have been given an opportunity of appearing before the Council and showing cause why such license should not be revoked or suspended.

13. Every person to whom a license has been granted under this or any other by-law for the purpose of carrying on any trade, calling, or business, shall permit the Inspector, or any other person duly authorized in that behalf, or any police officer, to inspect any house, place, premises, vehicle or thing in respect of which such licence has been granted, and any person who shall refuse to allow the Inspector, or any other person duly authorized in that behalf, or any police officer to inspect such house, place or premises, vehicle, or thing, shall be guilty of an infraction of this by-law and liable to the penalties thereof.
14. Before a license shall be granted to any person for the purpose of holding or exhibiting any circus or menagerie; or holding any show or carnival using ferris wheels, merry-go-rounds and/or other similar devices in the Municipality, such person shall give a bond to the Municipality in the amount of FIVE THOUSAND DOLLARS (\$5,000.00) satisfactory to the Municipal Solicitor, conditioned that in the event of an injury or damage being done or occasioned by such circus or menagerie, show or carnival to any person or to any property, either by reason of any street parade or any other thing the Municipality shall be saved harmless.
15. (a) Every hawker, huckster, and peddler, when plying his trade with a vehicle, shall have his name and address painted in a conspicuous place on both sides of every vehicle used by him for such trade satisfactory to the Inspector.  
  
(b) The Inspector shall furnish at the cost of the Municipality to each person taking out a license under this section a badge with the number of the license represented thereby, painted or stamped thereon, and such badge shall be the property of the Municipality.

(c) Every hawker, huckster, and peddler, plying his trade in any other manner than by or from a vehicle shall, when so plying his trade, carry upon his person the badge mentioned in the last preceding subsection.

(d) Every hawker, huckster, and peddler, when plying his trade and selling or offering for sale to the public any commodity which is sold by weight or measure shall have and use a lawful scale or measure capable of weighing or measuring any commodity sold or offered for sale by him.

(e) No person to whom a license has been granted as a hawker, huckster, or peddler shall either give, lend, rent, permit, or allow any other person to use the same or the badge issued with respect thereto.

(f) It shall be unlawful for any hawker, huckster, or peddler to stand on any street or lane in the Municipality for a longer period at any one time than may be required in making a sale and delivery of any commodity to a customer, nor shall any hawker, huckster or peddler be allowed to stand his vehicle for a longer time than five minutes at any one place on any street or lane in the Municipality, nor such vehicle be allowed to stand or remain on any street or lane within the block bounded by intersecting streets for a longer period than ten minutes during any period of two hours while engaged in the carrying on of his business.

16. (a) No person shall sell or offer for sale any book, magazine, or other periodical, other than a newspaper, on any street in the Municipality. This subsection shall not apply to the operator of any news stand, the operation of which has been approved in writing by the Inspector on recommendation of the Chief of Police and subject to such conditions as may be contained in such written approval.

(b) No person shall canvass or solicit business on any street in the Municipality from cards or samples or in any other manner whatsoever, for the sale of any goods, wares or merchandise, or any article or thing for future delivery.

17. (a) Every person intending to operate a restaurant, lunch counter or tea room or coffee shop, shall file a written application in duplicate with the Inspector for a license in respect of the premises in which it is intended to operate such restaurant, lunch counter, tea room or coffee shop and such application shall contain the following information:-

- (1) The name, occupation and full address of the applicant;
- (2) The nature of the license applied for;
- (3) The address of the premises where it is intended to operate the restaurant;
- (4) The maximum seating accommodation available;
- (5) If service is provided for persons in motor-vehicles, the number of vehicles for which parking space is provided shall also be stated.

(b) Upon receipt of the application referred to in subsection (a) the Inspector shall forward one copy of the said application to the Medical Health Officer who shall inspect the premises where the restaurant, lunch counter, tea room, or coffee shop is to be operated and report thereon, and no license shall be granted by the Inspector until he has received a report from the Medical Health Officer approving of the granting of the said license.

(c) No person shall operate or maintain any restaurant in which the dining-room contains boxes, booths, subdivisions or compartments wherein food is served or intended to be served;

- (1) Unless there is an entrance to each of such boxes, booths, subdivisions, or compartments of a width of at least equivalent to three-fourths of the length of the side of the box, booth, subdivision or compartment in which such entrance is;
- (2) And unless such entrance is free of any curtain, screen or other obstruction;
- (3) And unless at all times a clear view of the interior of each box, subdivision, or compartment is afforded through such entrance.
- (4) And unless any corridor or passage upon which any such box, subdivision or compartment opens is of a width of

at least forty inches free from any curtain, screen or other obstruction.

18. Notwithstanding anything to the contrary herein contained when any business, occupation, or calling is licensed and regulated or licensed under a special by-law of the Municipality the license fees to be paid to the Municipality shall be those provided for in the special by-law.
19. The said Schedule "A" is to read into this By-law as forming a part thereof.
20. In the event that the inspector shall require the approval of the premises by the Medical Health Officer of the Municipality before granting a license thereof, the premises shall be maintained in a proper sanitary condition during the period for which the license has been granted.
21. The Council may, by the unanimous vote of all the members present at any lawful meeting thereof, refuse in any particular case to grant the request of the applicant under this by-law.
22. The provisions of this by-law shall not apply to commercial travellers who sell goods, merchandise or any effects whatsoever or offer the same for sale to bona fide merchants, either wholesale or retail, within the Municipality for resale by such merchants in the ordinary course of their respective businesses.
23. Every person opening, keeping, carrying on, conducting or managing any trade, business, profession, occupation, calling, employment or purpose licensed under the provisions of this by-law shall keep and maintain in good order in and about the licensed premises and at his own expense shall keep a sufficient force of servants or employees for that purpose.
24. Every person who violates any of the provisions of this by-law or who suffers or permits any act or thing to be done in contravention of any of such provisions or who neglects to do or refrains from doing any thing required to be done by any of the provisions of this by-law shall be deemed to be guilty of an infraction thereof and liable to the penalties hereinafter provided.

25. Every person guilty of a breach of any of the provisions of this by-law shall be liable upon summary conviction to a penalty not exceeding Two Hundred Dollars (\$200.00) and costs for every such violation or where conviction is for failure to pay license fee the amount which should have been paid for such license shall be added, which said amount and penalty shall for the purpose of recovery be held to be one penalty, and in default of payment forthwith, may be levied by distress and the sale of the goods and chattels of the offender and in case of there being no distress found out of which the said penalty and cost may be levied the offender may be committed to a Common Gaol for a period not exceeding sixty (60) days.
26. This by-law shall come into force and take effect on the 15th day of January A.D. 1951.
27. All Trades License By-laws of the Municipality and all amendments thereto heretofore passed by the Council are hereby repealed.
28. This By-law may be cited for all purposes as the "BURNABY TRADES LICENSE BY-LAW, 1950."

SCHEDULE "A"

1. AUTO CAMPS, APARTMENTS, ROOMING HOUSES

From every person letting individual rooms, suites of rooms, or lodging for hire either in a hotel, rooming house, apartment house, lodging house, auto camp or elsewhere, or whether or not board or meals are supplied to the occupants thereof, fifty (\$0.50) cents for every six months for each room let or available for letting. Provided, however, that persons having not more than two rooms available for letting shall not be required to take out or hold a licence under this clause.

2. AMBULANCES, CABS, ETC.

From every person owning or keeping cabs, carriages, carts, ambulances, drays, trucks, motor cars, automobiles, or other conveyance or vehicle for hire (whether with or without driver) Ten (\$10.00) Dollars for each such conveyance or vehicle for every six months.

3. AUTO BODY REPAIRERS

From every person carrying on the business of repairing and painting automobile bodies the sum of Ten (\$10.00) Dollars every six months.

4. AGENTS

From every person who, either on his own behalf or as agent for another, sells, or solicits or takes orders for the sale of retail goods, wares or merchandise to be supplied by any person not doing business in the Municipality, (\$50.00) Fifty Dollars for every six months.

5. AUCTIONEERS

From every person selling property by auction (not being a Crown Officer selling Crown property by auction or a Sheriff, Sheriff's Officer or Bailiff selling lands, goods or chattels under a judgment or a satisfaction of rent or taxes), Twenty-five (\$25.00) Dollars for every six months.

6. ART DEALERS

From every person carrying on the business of an art dealer, or photo supply dealer, Five (\$5.00) Dollars for every six months.

7. ADVERTISING AGENCIES

From every advertising agent the sum of Ten (\$10.00) Dollars for every six months.

8. BARBERS.

From every person carrying on the business of a barber, the sum of \$7.50 for the first barber-chair situated in the premises plus the sum of \$2.50 for each additional barber-chair situated in the premises, every six months. The maximum licence fee shall be Twenty (\$20.00) for six months.

9. BUILDING CONTRACTORS

See Contractors.

10. BEAUTY PARLORS

From every person carrying on the business of a beauty parlour the sum of (\$10.00) Ten Dollars for every six months.

11. BANKS

From every bank or person carrying on the business of a banker at one place of business One Hundred (\$100.00) Dollars for every six months and a further sum of Fifty (\$50.00) Dollars for every six months for each additional place of business.

12. BEVERAGE MANUFACTURERS & WHOLESALERS

From every person carrying on the business of manufacturing beverages for human consumption or of selling the same wholesale, a sum of Ten (\$10.00) Dollars for every six months.

13. BOWLING ALLEYS

From every person keeping a bowling alley for hire or profit Seven Dollars and Fifty Cents (\$7.50) for each alley or runway for every six months.

14. BICYCLE SHOPS

See Retail Traders.

15. BATH HOUSES

From every person carrying on the business of a bath house or giving massage treatments, the sum of Twelve Dollars and Fifty Cents (\$12.50) for every six months.

16. BOAT CHARTERERS (COMMERCIAL)

From every person engaged in leasing, supplying, or chartering boats or vessels for commercial fishing, the sum of Twenty (\$20.00) Dollars for every six months.



17. BOAT CHARTERERS (SPORT)

From every person engaged in hiring, leasing, chartering boats for pleasure or for sport fishing, the sum of Ten (\$10.00) Dollars for every six months.

18. BRICKYARDS

From every person carrying on the business of manufacturing bricks, tile, concrete blocks or any other similar commodity, the sum of Ten (\$10.00) Dollars every six months.

19. BUILDERS

From every person who constructs or erects or causes to be constructed or erected, houses or other buildings as a business enterprise with the object of selling and not occupying same, the sum of Ten (\$10.00) Dollars every six months.

20. BILL POSTERS

From every person carrying on the business of erecting or maintaining painted, posted, illuminated or other advertising signs on property which does not belong to the advertiser, the sum of Twenty (\$20.00) Dollars every six months.

21. BOOK AGENTS

From every person who sells or offers for sale books, magazines, or other periodicals, not being Bibles or religious tracts, by canvassing from house to house or place to place within the Municipality the sum of Two Dollars and fifty cents (\$2.50) every six months.

22. BAKERIES (Wholesale)

From every person who carries on the business of baking pies, cakes, bread, pastries or any other article and sells same by wholesale, the sum of Five (\$5.00) Dollars every six months.

23. CIRCUSES.

From any person who exhibits a public circus, menagerie, hippodrome, horse-show, or pony show the amount of One Dollar per day for each person employed or engaged in the said public circus, menagerie, hippodrome, horse-show, or pony show, provided however, that the minimum license fee per day shall be Fifty Dollars and the maximum license fee per day shall be Five Hundred Dollars.

Provided further that no such license shall be required in respect of any public circus, menagerie, hippodrome, horse-show, or pony show the entire proceeds of which, over and above bona fide expenses,

are devoted or given to any church, school, hospital, charitable, war fund or patriotic purpose.

24. CARNIVALS

From every person who exhibits and/or operates ferris-wheels, merry-go-rounds or other similar rides, games of skill, mid-ways and/or other similar attractions the sum of One Dollar per day for each person employed or engaged in the said enterprise, provided however, that the minimum license fee per day shall be Fifty Dollars and the maximum license fee per day shall be Five Hundred Dollars. Provided that no such license fee shall be required when the entire proceeds of which, over and above bona-fide expenses, are devoted or given to any church, hospital, charitable or patriotic purpose.

24A CHRISTMAS TREES

From every person carrying on the business of selling trees commonly known as Christmas Trees, the sum of One Dollar every six months.

24B CANVASSERS

From every person who either on his own behalf, or as an agent for another, solicits or takes orders for work or services to be performed outside of the municipality by a person not doing business in the municipality, the sum of Ten Dollars every six months.

24C COLD STORAGE PLANTS

From every person carrying on the business of leasing or renting cold storage lockers or space, the sum of Ten Dollars every six months.

25. CEMETERIES

From every person carrying on business of a Cemetery, *Twenty Dollars* for every six months.

26. CHIMNEY SWEEPS

From every person carrying on the business of a chimney sweep, Five Dollars for every six months.

27. CLEANERS

From every person carrying on the business of a presser, cleaner, and dyer, Ten Dollars for every six months.

28. CANNING

From every person carrying on the business of canning, curing fish or fruit processing, Ten Dollars for every six months.

29. CHINA DEALERS

See Retail Traders

30. CONFECTIONERS

See Retail Traders.

CONTRACTORS

31. For the purpose of this clause the following words and terms shall have the meanings hereby assigned to them:-

"Building Contractor" shall mean any person who undertakes to do or perform any construction, building, carpentry, plastering, lathing, shingling, brickwork, masonry, or concrete work on any building or premises for any person other than a licensed Building Contractor.

"Electrical Contractor" shall mean any person who does electrical installing or work, or who does electrical jobbing for any person other than a licensed Electrical Contractor.

"Excavating Contractor" shall mean any person who undertakes to excavate any ditch, basement, drain or foundation for any person other than a licensed Excavating Contractor.

"General Contractor" shall mean any person who holds all of the licenses defined in this Clause.

"Heating Contractor" shall mean any person who does heating equipment installing or work, or who does heating equipment jobbing for any person other than a licensed Heating Contractor.

"Land Clearing Contractor" shall mean any person who clears land or brush, trees, stumps, stones, or any other material for any person other than a licensed Land Clearing Contractor.

"Moving Contractor" shall mean any person who undertakes to move any building or structure from one premises to another for any person other than a licensed Moving Contractor.

"Painting Contractor" shall mean any person who paints the exterior or interior of any building or who does interior decorating of any kind for any person other than a licensed Painting Contractor.

"Plumbing Contractor" shall mean any person carrying on the trade or business of plumbing, or who contracts to do plumbing, or who does jobbing plumbing for any person other than a licensed Plumbing Contractor.

"Road Building Contractor" shall mean any person who builds, maintains, constructs, or hard-surfaces any street, road, lane, highway, sidewalk or foot path for any person other than a licensed Road Building Contractor.

"Sanitary Contractor" shall mean any person who cleans or installs septic tanks for any person other than a licensed Sanitary Contractor.

"Wrecking Contractor" shall mean any person who undertakes to demolish any building or structure for any person other than a licensed Wrecking Contractor.

the sum of Ten Dollars every six months.

From every person carrying on the business of an Electrical Contractor the sum of Ten Dollars every six months.

From every person carrying on the business of a Heating Contractor the sum of Ten Dollars every six months.

From every person carrying on the business of a Painting Contractor the sum of Ten Dollars every six months.

From every person carrying on the business of a Plumbing Contractor the sum of Ten Dollars every six months.

From every person carrying on the business of a Sanitary Contractor the sum of Ten Dollars every six months.

From every person carrying on the business of a Road Building Contractor the sum of Ten Dollars every six months.

From every person carrying on the business of an Excavating Contractor the sum of Ten Dollars every six months.

From every person carrying on the business of a Wrecking Contractor the sum of Ten Dollars every six months.

From every person carrying on the business of a Moving Contractor the sum of Ten Dollars every six months.

From every person operating a yard for the storage of contractors equipment, material, supplies, tools or machines the sum of Five Dollars for every six months.

*✓* From every person operating a yard for the storage of contractors equipment, material, supplies, tools or machines the sum of Five Dollars for every six months.

32 . DAIRIES

From every person carrying on the business of pastuerizing, bottling or distribution of milk from premises situated within the Municipality the sum of Ten Dollars for every six months.

33. DRESSMAKERS

From every person carrying on the business of a dressmaker, Two Dollars and fifty cents for every six months.

34. DANCE HALLS

From every person operating a dance hall the sum of Twenty Dollars every six months or the sum of Five Dollars for each dance.

35. DANCING ACADEMIES

From any person carrying on the business of a teacher of dancing or operating a dancing academy, the sum of Five Dollars for the first person employed in the business and the sum of Two Dollars and fifty cents for each additional person ordinarily employed, for every six months, with a maximum of Twenty Dollars.

36. DOG & CAT SHOWS

From every person who exhibits a dog show, or dog and cat show, the sum of Two Dollars and fifty cents for each day of such exhibition.

37. DRUG STORES

See Retail Traders.

38. DRY GOODS STORES

See Retail Traders.

39. ELECTRICAL STORES

See Retail Traders.

40. EXPRESS COMPANIES

From every person carrying on the business of an express company Ten Dollars for every six months.

41. EXPLOSIVES

From every person dealing in explosives the sum of Five Dollars for every six months.

42. ELECTRICIANS

See Contractors.

43. FOUNDRIES

From every person carrying on the business of a foundry, the sum of Twenty Dollars for each six months.

44. FUEL DEALERS

(a) From every person carrying on the business of a fuel dealer for the sale of fuel of any kind from premises situated within the Municipality, the sum of Ten Dollars every six months.

(b) From every person carrying on the business of a fuel dealer for the sale of fuel of any kind from premises situated outside the Municipality, the sum of Ten Dollars every six months.

45. FUEL PEDDLER

From every person who goes from place to place or house to house taking orders for or selling or offering for sale or who takes orders for or sells or offers for sale or vends on any street, lane or public place in the Municipality any kind of fuel whether in full loads or parts of a load and whether such person is so acting on his own behalf or as a servant or employee of another, fifty dollars for every six months.

46. FUNERAL PARLORS

From every person carrying on the business of a funeral parlor the sum of Twenty Dollars each six months.

47. FLORISTS

See Retail Traders.

48. FUR BREEDERS

From every person carrying on the business as a breeder of fur bearing animals, Two Dollars and fifty cents for every six months.

49. FUR TRADERS

From every person carrying on the business of a fur trader, Twenty-five Dollars for every six months.

50. FURNITURE STORES

See Retail Traders.

51. FISH AND VEGETABLE PEDDLERS

From any person carrying on the business of a fish peddler or vegetable peddler the sum of Ten Dollars for every six months

52. FLOUR & FEED STORES

See Retail Traders.

53. FINANCING AGENTS

From every person carrying on the business of financing for others the sale or purchase of goods on the security of conditional sales as defined by the "Conditional Sales Act", or lending money on personal property by way of chattel mortgage, the sum of Twenty Dollars every six months.

54. GROCERY STORES

See Retail Traders.

55. GASOLINE SERVICE STATIONS

From every person carrying on the business of a gasoline service station, the sum of Five Dollars every six months.

Provided, however, that this clause shall not apply to any person who operates a garage and pays a license therefor.

56. GARAGES

From every person who carries on the business of a garage for the sale or storage of automobiles or trucks the sum of Ten Dollars every six months, and where such garage is used for the repair of automobiles and trucks, an additional fee of Seven Dollars and Fifty Cents for every six months shall be imposed.

57. GENERAL STORES

See Retail Traders.

58. GASOLINE DELIVERY TRUCKS

From the owner of every truck used for the delivery of gasoline and oils to service stations, with weight when loaded exceeding five tons, Twenty Dollars for every six months, with an additional charge of Two Dollars for each ton exceeding five tons.

59. GENERAL CONTRACTORS

See Contractors.

60. HEATING CONTRACTORS

See Contractors.

61. HARDWARE STORES

See Retail Traders.

62. HATCHERIES

From every person carrying on the business of a hatchery, who buys eggs for hatching and sells or offers for sale chicks or turkey poults, and who buys chicks or turkey poults for re-sale, the sum .

of Twenty Dollars for every six months provided, however, that where the hatchery has a capacity of less than 20,000 eggs at one sitting, the license fees payable shall be Ten Dollars every six months.

63. HEAVY EQUIPMENT

From every person being the owner and/or operator of a bulldozer, power shovel, clam shell, power hoe, trencher, drag line, power grader, or any other heavy equipment, Five Dollars every six months for each separate and distinct machine.

64. JEWELLRY STORE

See Retail Traders.

65. JUNK DEALER

From every person carrying on the business of a junk dealer, Fifty Dollars for every six months.

66. KINDERGARTEN

From every person carrying on the business of a kindergarten, the sum of Two Dollars and fifty cents every six months.

67. LUMBER YARDS

From every person carrying on the business of a lumber yard for the sale by retail of lumber and building supplies, except hardware, Twenty Dollars for every six months.

68. LIVERY STABLES

From every person keeping a livery stable, Twenty Dollars for every six months.

69. LAUNDRY OFFICES

From every person carrying on the business of a laundry or cleaners office the sum of Ten Dollars for every six months.

70. LAUNDRIES

From any person keeping or carrying on a public laundry, the sum of Ten Dollars for every six months.

71. LOGGING

From every person carrying on the business of logging, the sum of Ten Dollars for every six months.

72. LAND CLEARING CONTRACTORS

See Contractors.

73. MEAT MARKETS

See Retail Traders.



74. MACHINE SHOPS

From every person carrying on the business of a machine shop the sum of Ten Dollars every six months.

75. MEMORIAL RETAILERS

From every person who carries on the business of manufacturing and/or selling memorials, the sum of Ten Dollars every six months.

76. MANUFACTURER

From every person carrying on the business of a manufacturer, the sum of Fifty Dollars every six months.

77. MILLS

From every person carrying on the business of a saw mill, shingle mill, pole and tie mill, Twenty Dollars for every six months.

78. MISCELLANEOUS

From every person following, within the Municipality, any profession, business, trade, occupation, employment or calling not hereinbefore enumerated or who enters into or carries on any contract to perform any work or furnish any material, Ten Dollars for every six months.

79. MISCELLANEOUS RETAILERS

See Retail Traders.

80. MAIL ORDER AGENCIES

From any person who either on his own behalf or as agent for another carries on a mail order business or partly the business of a retail or wholesale and retail trader or merchant and partly a mail order business, the sum of Fifty Dollars for every six months.

81. MUSICAL INSTRUMENTS

See Retail Traders.

82. MILLINERS

From every person carrying on the business of a milliner, the sum of Two Dollars and fifty cents for every six months.

83. MILK PRODUCERS

From every person who keeps one or two cows and/or goats and sells milk therefrom the sum of Two Dollars and fifty cents every six months plus the sum of One Dollar for each additional cow or goat over and above two. Provided, however, that the maximum license fee shall not exceed the sum of Twenty Dollars every six months.

84. MUSIC TEACHERS

From every person carrying on the business of a music teacher or elocution teacher, the sum of Five Dollars for the first person employed in the business and the sum of Two Dollars and fifty cents for each additional person ordinarily employed for every six months, with a maximum of Twenty Dollars.

85. MONEY-LENDERS

From every person carrying on the business of lending money, or advancing money on salaries, either earned or unearned, the sum of <sup>Fifty</sup> Twenty Dollars every six months. Provided that this clause shall not include any person carrying on the business of a banker or pawnbroker.

86. MILK VENDORS

From every person carrying on the business of a milk vendor whose dairy is situated outside the municipality, the sum of Ten Dollars every six months.

87. NURSERIES

From every person carrying on the business of producing or growing plants, trees, shrubs, or flowers for sale, the sum of Ten Dollars every six months.

88. NEW CAR DEALERS

From every person carrying on the business of a dealer in new automobiles or motor cars or a dealer in both new and second-hand automobiles or motor cars, Fifty Dollars for every six months. The holder of any license under this shall also be entitled to carry on the business of selling automobile accessories, gasoline, oil and supplies and of repairing automobiles or motor cars without taking out any further license therefor.

89. OIL REFINERIES

From every person carrying on the business of an oil refinery, Twenty Dollars for every six months.

90. OIL STORAGE PLANTS

From every person carrying on the business of operating an oil storage plant for the storage of oils of all kinds and the distribution of same, other than a refinery, the sum of Twenty Dollars every six months.

91. OPTICIANS

From every person carrying on the business of an optician, Fifteen Dollars for every six months.

92. PEAT PRODUCERS

From every person carrying on the business of producing peat products the sum of Ten Dollars every six months.

93. PAINTERS & INTERIOR DECORATORS

See Contractors.

94. PLUMBERS

See Contractors.

95. PHOTOGRAPHERS

From every person carrying on the business of a photographer, Two Dollars and fifty cents for every six months.

96. PUBLIC HALLS

From every person who operates a public hall for gain, other than a dance hall, the sum of Ten Dollars for every six months.

97. PEDDLERS

From every hawker, peddler, or huckster, Ten Dollars for every six months.

98. POOL HALLS

From every person keeping premises where a billiard table or pool table is used for hire or profit, Seven Dollars and fifty cents for each table for every six months.

99. PRINTERS

From every person carrying on the business of mimeographing and printing the sum of Ten Dollars every six months.

100. PICTURER & FINE ARTS

From every person carrying on the business of an art or photo supply dealer, Five Dollars for every six months.

101. PAWN BROKERS

From every person carrying on the business of a pawnbroker, One Hundred and twenty-five Dollars for every six months.

102. PARKING LOTS

From every person carrying on the business of any auto-parking lot, the sum of Ten Dollars for every six months.

103. PRIVATE BOARDING SCHOOLS

From every person carrying on the business of a private boarding

school, the sum of Ten Dollars for every six months.

104. PRIVATE SCHOOLS

From every person carrying on the business of a Private or Trades School, the sum of Ten Dollars for every six months.

105. PRIVATE HOSPITALS

From every person carrying on the business or operating a private hospital or nursing home, Ten Dollars for every six months.

106. PRIVATE PATROL AGENCY

From every person who by contract or agreement undertakes to watch or patrol the premises of more than one person for the purpose of guarding or protecting persons or property against robbery, theft, burglary, or other hazards, the sum of Two Dollars and fifty cents every six months.

107. PUBLIC MARKETS

From every person owning or operating any premises containing five or more stalls, spaces, divisions, or compartments, individually rented, occupied or operated, for the purpose of displaying or selling merchandise, the sum of Ten Dollars every six months.

108. PLUMBING SUPPLIES

See Retail Traders.

109. REAL ESTATE AGENCIES

From every real estate and/or <sup>life</sup> fire insurance agent the sum of Ten Dollars for every six months.

110. RADIO SERVICES

From every person carrying on the business of a radio repairer, Five Dollars for every six months.

111. RIDING ACADEMIES

From every person engaged in the business of a riding academy, Ten Dollars for every six months.

112. RESTAURANTS

From every person carrying on the business of a restaurant, lunch room or coffee shop with seating accommodation up to and including twenty people, the sum of Five Dollars every six months, with an additional charge of Twenty-Five Cents for each additional seat over twenty, every six months. Provided, however, the maximum license fee every six months shall not exceed the sum of Twenty Dollars.

113. RESTAURANTS - (DRIVE-IN)

From every person carrying on the business providing a parking lot for the parking of vehicles in which the occupants are served meals or refreshments of any kind, the sum of Five Dollars every six months in addition to the license required by Clause 112.

114. RETAIL TRADERS

From every person carrying on the business of a retail trader the sum of ~~Six~~ Dollars every six months for the first three hundred sqft. of floor space from which the goods are sold or offered for sale plus the sum of One Dollar for each additional one hundred square feet of floor space or fraction thereof.

Provided, however, the minimum license fee shall be the sum of ~~Six~~ Dollars every six months.

115. SECOND-HAND CAR DEALERS

From every person carrying on the business of a dealer in second-hand or used automobiles or motor cars, the sum of Twenty Dollars every six months.

116. SHOE REPAIRERS

From every person carrying on the business of a boot and shoe repairer, Five Dollars for every six months.

117. SECOND HAND DEALERS

See Retail Traders.

118. SHOE STORES

See Retail traders.

119. STEEL FABRICATING PLANTS

From every person carrying on the business of steel and/or iron fabricating, Twenty Dollars for every six months.

120. SHOOTING GALLERIES

From every person keeping a rifle gallery or shooting gallery for hire or profit, Five Dollars for each range or target for every six months.

121. STATIONERY DEALERS

See Retail Traders.

122. SPORTING GOODS STORES

See Retail Traders.

123. SHIP BUILDERS

From every person carrying on business of a shipbuilder or shipyard, Ten Dollars for every six months.

124. STEVEDORING

From any person who carries on the business of a stevedore or who takes contracts to load or unload ships, the sum of Twenty-five Dollars for every six months.

125. SAND & GRAVEL SUPPLIERS

From every person carrying on the business of supplying sand and gravel, the sum of Ten Dollars for every six months.

126. SKATING RINKS

From every person carrying on the business of a skating rink or roller-rink the sum of Fifteen Dollars for every six months.

127. SCAVENGERS

From every person carrying on the business of a scavenger, Five Dollars for every six months.

128. SIGN PAINTING

From every person carrying on the business of sign writing and/or painting the sum of Ten Dollars every six months.

129. TRUCKS (MERCHANTS)

From every person being licensed as a retail trader, the sum of Two Dollars and fifty cents every six months for each truck or delivery conveyance used for the delivery of goods, wares, or produce from his place of business.

130. TRUCKS (DELIVERY)

From every owner or driver of every truck or delivery conveyance plying for hire or used for the delivery of wood, coal, merchandise, or other commodity, Seven Dollars and fifty cents for every six months.

131. TRUCKS (COLLECTION)

From the owner or driver of any truck used for the collection of produce, wood, merchandise or other commodities from premises within the Municipality not in the occupation of such owner or driver, Seven Dollars and fifty cents for every six months, for each truck.

132. THEATRES

From the proprietor, lessee, or manager of any theatre, moving picture theatre, amusement hall, concert hall, music hall, entertainment or exhibition, according to the seating capacity thereof (allowing 704 square inches for each seat) the following respective amounts:

Seating capacity of 975 or more, two hundred dollars for six months, one hundred dollars for three months, fifty dollars for one month and ten dollars for one day;

Seating capacity of 500 and not more than 974, seventy-five dollars for six months, forty dollars for three months, twenty dollars for one month and five dollars for one day;

Seating capacity of 250 and not more than 499, fifty dollars for six months, thirty dollars for three months, fifteen dollars for one month and five dollars for one day.

Seating capacity of not more than 249, twenty dollars for six months, ten dollars for three months, five dollars for one month, and three dollars for one day.

Provided, that where one building contains more than one theatre, hall or other place of amusement within the scope of this clause, a separate license shall be payable in respect of each of them;

Provided further, that no such license shall be required in respect of any performance, concert, exhibition, or entertainment, the entire proceeds of which, over and above actual bona-fide expenses, are devoted or given to any church, school, hospital, charitable, war fund, or patriotic purposes.

133. TRANSFER FEES

Where any license or licenses is or are transferred, a fee equal to five per centum (5%) of the total fee for such license or licenses shall be charged, provided that the minimum fee for a transfer shall be One Dollar.

134. TAILORS

From every person carrying on the business of a tailor, Ten Dollars for every six months.

135. TINSMITHS

From every person carrying on the business of a sheet metal worker or tinsmith the sum of Ten Dollars every six months.

136. TOBACCONIST

See Retail Traders.

137. TRANSIENT TRADERS

From every transient trader doing business within the limits of the Municipality, One Hundred Dollars for every six months or part thereof in addition to the fee for any other license under this schedule.

138. TRANSIENT HAIRDRESSER

From every transient hairdresser, Fifty Dollars for every six months.

139. TRANSIENT REAL ESTATE AGENT

From every transient real estate agent or land agent, Fifty Dollars for every six months.

140. TRUST & INVESTMENT COMPANY

From any person carrying on the business of a trust company, investment, loan or mortgage agency, society, or company, the sum of Fifty Dollars for every six months.

141. TRADE SCHOOLS

See Private Schools.

142. TRAILER CAMPS

From every person operating a trailer camp, whether in connection with an existing auto court or not, Five Dollars every six months.

143. TRAVEL AGENCY

From every person carrying on the business of a travel agency the sum of Ten Dollars every six months.

144. UPHOLSTERERS.

From every person carrying on the business of upholstering or re-upholstering furniture the sum of Ten Dollars every six months.

145. VULCANIZING SHOPS

From every person carrying on the business of a vulcanizing shop the sum of Ten Dollars for every six months.

146. WOODWORKING SHOPS

From every person carrying on the business of a woodworking shop the sum of Ten Dollars every six months.

147. WOOD FABRICATING PLANTS

From every person carrying on the business of a wood fabricating plant the sum of Twenty Dollars every six months.

148. WATCH REPAIRERS

From every person carrying on the business of a watchmaker, Five



Dollars for every six months.

149. WHOLESALERS

From every person carrying on the business of a wholesale or whole-  
sale and retail merchant or trader, the sum of Twenty Dollars every  
six months.

Any person paying a license under this clause shall be entitled to  
change his place of business at pleasure, but not to carry on busi-  
ness at two places at the same time under one licence.
