

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3090

A BY-LAW to authorize the sale of South half of Lot 24, and Lot 25, of Block 8, D.L.93. Group 1. New Westminster District, Map No. 1525.

WHEREAS The Corporation of the District of Burnaby has acquired all and singular those certain parcels or tracts of land and premises known as the South half of Lot Twenty four (24  $\frac{1}{2}$ ) and Lot Twenty five (25) of Block Eight (8) of District Lot Ninety three (93) Group One (1) New Westminster District, Map No. 1525, for Corporate purposes.

AND WHEREAS the said lands and premises are no longer required for Corporate purposes.

AND WHEREAS the value of the said lands and premises does not exceed the sum of Two thousand (\$2,000.00) dollars.

AND WHEREAS the persons hereinafter mentioned have offered to purchase the said lands for the consideration hereinafter mentioned.

AND WHEREAS pursuant to Section 43 (a) of the "District of Burnaby Debt Refunding Act, 1940" the approval of the Honourable, the Minister of Municipal Affairs, is required before any of the capital assets of the Corporation may be disposed of:

AND WHEREAS the Honourable, the Minister of Municipal Affairs, has on the 5th day of December, 1950 granted approval for the sale of the hereinafter mentioned lands and premises:

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:-

1. That Lot Twenty five (25) of Block Eight (8) District Lot Ninety three (93) Group One (1) New Westminster District, Map No. 1525, be sold and disposed of to Mona Annie Eva Lowe

and Lloyd Cuthbert Lowe of 2750 Randolph Avenue, in the Municipality of Burnaby, Province of British Columbia, as Joint Tenants, for the sum of One thousand seven hundred (\$1,700.00) dollars.

2. That the South half of Lot Twenty four (24S $\frac{1}{2}$ ) Block Eight (8) District Lot Ninety three (93) Group One (1) New Westminster District, Map No. 1525, be sold and disposed of to Peter Andrew Faryna (Engineer) and Audrey Gwendolyn Faryna, both of 2661 Randolph Avenue, in the Municipality of Burnaby, Province of British Columbia, as Joint Tenants, for the sum of Two hundred and fifty (\$250.00) dollars.

3. That upon the payment of the said sum of One thousand, seven hundred (\$1,700.00) by the said Mona Annie Eva Lowe and Lloyd Cuthbert Lowe; and upon payment of the said sum of Two hundred and fifty (\$250.00) dollars by the said Peter Andrew Faryna and Audrey Gwendolyn Faryna, conveyance to the said Mona Annie Eva Lowe and Lloyd Cuthbert Lowe of Lot Twenty five (25) Block Eight (8) District Lot Ninety three (93) Group One (1) New Westminster District, Map No. 1525 be executed under the seal of the Corporation by the Reeve and Clerk and be delivered to the said Mona Annie Eva Lowe and Lloyd Cuthbert Lowe, and that conveyance to the said Peter Andrew Faryna and Audrey Gwendolyn Faryna of the South half of Lot Twenty four (24 S $\frac{1}{2}$ ) Block Eight (8) District Lot Ninety three (93) Group One (1) New Westminster District, Map No. 1525 be executed under the Seal of The Corporation by the Reeve and Clerk and be delivered to the said Peter Andrew Faryna and Audrey Gwendolyn Faryna.

4. This By-law may be cited as "CRAIG PROPERTY SALE BY-LAW 1950"
