Whereas it is necessary and desirable to borrow the maximum sum of Six Hundred

Thousand - - - - (\$600,000.00) - - - - Dollars from THE ROYAL BANK OF CANADA to meet the current lawful expenditure of the corporation which becomes payable out of the annual revenue:

And Whereas the said THE ROYAL BANK OF CANADA has requested the corporation to secure the payment of the same as hereinafter set forth:

Be It Therefore Enacted by the Municipal Council of the Corporation of the

District of Burneby as follows:-

1. That the said corporation be and it is hereby authorized to borrow from THE ROYAL BANK OF CANADA the maximum sum of **Six** Hundred

Thousand - - - (\$600,000.00) - - - - - - Dollars.

2. That the said corporation be and it is hereby authorized to pay to the said bank interest on the said maximum sum of Six Hundred Thousend - - - - -

-- (\$800,000.00) ---- Dollars at the maximum rate

of Four (4 %) per centum per annum which may be paid or allowed in advance by way of discount, or otherwise howsoever as they may deem best.

- 4. That the obligation or obligations to be given therefor shall be a promissory note or notes signed by the Mayor or Reeve and Finance Committee, and the Clerk of the corporation, and shall bear the corporate seal of the corporation, and shall be for a period within the current year, but may be renewed from time to time as circumstances may require.
- 5. There is hereby set aside as security for the payment of such money with all interest thereon respectively, the whole of all unpaid taxes assessed and levied by the said corporation, as shown in the Schedule to this By-Law.
