A BY-LAW to further amend "The Burnaby Town Planning By-law 1948".

WHEREAS applications have been received by the Municipal Council of The Corporation of the District of Burnaby for certain amendments to the "Burnaby Town Planning By-law 1948".

AND WHEREAS THE said applications have been referred to the "Burnaby Town Planning Commission" for consideration and recommendation:

AND WHEREAS the said Texts Planning Commission has recommended to the Council that the undermentioned amendments to the By-law be made.

AND WHEREAS the Council of The Corporation of the District of Burnaby, has pursuant to the provisions of Section 10 and 11 of the Town Planning Act, held a hearing therein after giving notice of the time and place of such hearing in manner and form provided by the said Act.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE DISTRICT OF BURNABY ENACTS AS FOLLOWS:

1. Paragraph 9 of the Burnaby Town Planning By-law 1948 is hereby amended by adding as paragraph (u) the following:

 (u) Parking lot, when used in conjunction with Commercial premises contiguous thereto, or when used in conjunction with a business or use lawfully carried on within said Residential zone.

2. Schedule 6 of Burnaby Town Planning By-law 1948 is hereby smended by adding thereto the following:

EAST HEAVY INDUSTRIAL ZONE.

All that area comprised of Lot 10 of District Lot 10, Group One (1) New Westminster District, Save and Except part on Sketch 10526 and Save and Except part on Plan numbered 6731.

3. This By-law may be cited as "BURNABY TOWN PLANNING BY-LAW 1948, AMENDMENT EY-LAW NO. 2, 1951."
