A BY-LAW to authorize The Corporation of the District of Burna by to convey certain lands to the Burna by School Board.

REGI WHEREAS certain lands were crown granted to The Corporation the District of Burnaby by Crown Grant No. 158/227 dated the 8th OP day of March, 1912, in trust for School purposes.

THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:-

1. Authority is hereby given to the Reeve and Clerk of The Corporation of the District of Burnaby to convey ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Municipality of Burnaby, Province of British Columbia, and being a portion of Block 19, being a subdivision of Let 152 (are a portion of Block 19, being a subdivision of Lot 153, Group 1, New Westminster District, and more particularly described as follows:

Commencing at the north east corner of said Block 19; thence S 36° 42' W. along the Easterly boundary of said Block 19, 349.47 feet; then ce N 53°18' W 132.0 feet.

thence N 36° 42' E. and parallel to said easterly boundary of said Block 19, 330.0 feet to the Northerly boundary of said Block 19;

thence S 61° 42' E. along the said northerly boundary of said Block 19, 133.42 feet, more or less to the point of commencement said to contain one acre more or less as shown outlined in Red Colour on plan attached to said Crown Grant.

2. This By-law may be cited for all purposes as "BURNABY SCHOOL PROPERTY CONVEYANCE BY-LAW 1951."
