



THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3118.

A BY-LAW to authorize The Corporation of the District of Burnaby to convey certain lands to the Burnaby School Board.

WHEREAS certain lands were crown granted to The Corporation of the District of Burnaby by Crown Grant No. 158/227 dated the 8th day of March, 1912, in trust for School purposes.

AND WHEREAS the Council of The Corporation of the District of Burnaby deem it advisable and in the public interest that such land should now be conveyed to The Board of School Trustees of School District No. 41 (Burnaby.)

THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:-

1. Authority is hereby given to the Reeve and Clerk of The Corporation of the District of Burnaby to convey ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Municipality of Burnaby, Province of British Columbia, and being a portion of Block 19, being a subdivision of Lot 153, Group 1, New Westminster District, and more particularly described as follows:

Commencing at the north east corner of said Block 19;
thence S $36^{\circ} 42'$ W. along the Easterly boundary of said Block 19, 349.47 feet;

thence N $53^{\circ} 18'$ W 132.0 feet.

thence N $36^{\circ} 42'$ E. and parallel to said easterly boundary of said Block 19, 330.0 feet to the Northerly boundary of said Block 19;

thence S $61^{\circ} 42'$ E. along the said northerly boundary of said Block 19, 133.42 feet, more or less to the point of commencement said to contain one acre more or less as shown outlined in Red Colour on plan attached to said Crown Grant.

2. This By-law may be cited for all purposes as "BURNABY SCHOOL PROPERTY CONVEYANCE BY-LAW 1951."
