

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3119

A BY-LAW to further amend "The Burnaby Town Planning By-law 1948".

WHEREAS applications have been received by the Municipal Council of The Corporation of the District of Burnaby for certain amendments to the "Burnaby Town Planning By-law 1948".

AND WHEREAS the said applications have been referred to the "Burnaby Town Planning Commission" for consideration and recommendation:

AND WHEREAS the said Town Planning Commission has recommended to the Council that the undermentioned amendments to the By-law be made.

AND WHEREAS the Council of The Corporation of the District of Burnaby, has pursuant to the provisions of Section 10 and 11 of the Town Planning Act, held a hearing therein after giving notice of the time and place of such hearing in manner and form provided by the said Act.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:-

1. Schedule 3 of the Burnaby Town Planning By-law 1948 is hereby amended by adding as Paragraph (ii) the following:

(ii) All that area at the South East corner of Royal Oak Avenue and Irvine Street comprised of the North 132 feet of Block 1, District Lot 94 Central.

2. Schedule 5 of the Burnaby Town Planning By-law 1948 is hereby amended by adding thereto the following:

LIGHT INDUSTRIAL ZONE

South Area

All that area comprised of Lots 8 to 12 inclusive, and Lot 2 (Save and except North 132 feet) all in District Lot 94 Central.

3. Schedule 4 of the "Burnaby Town Planning By-law 1948 is hereby amended by adding as Paragraphs (23) and (24) the following:

(23) All that area on the south side of Windsor Street between Gilley Avenue and Colborne Avenue, comprised of Lot 5, Block 1, District Lot 96.

(24) All that area on the South West corner of Cumberland Street and 13th Avenue comprised of Lot 15, Lots 2 and 3, Block 2, District Lot 25.

3. This By-law may be cited as "BURNABY TOWN PLANNING BY-LAW 1948, AMENDMENT BY-LAW NO. 3, 1951."

DONE AND PASSED in Open Council the Fourteenth (14th) day of May, A. D. 1951.

RECONSIDERED AND FINALLY PASSED by the Municipal Council on the Twenty-first (21st) day of May, A. D. 1951.

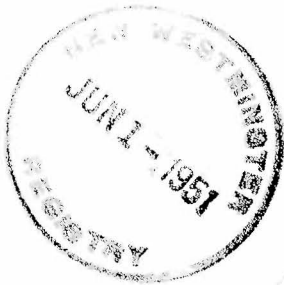
