BY-LAW NO. 3122

A BY-LAW to authorize the sale to John Douglas Hall of Lot Ten (10) of Block Twenty two (22), of District Lot One hundred and Fifty nine (159), Group One (1), Map No. 1241, New Westminster District.

WHEREAS the lands hereinafter mentioned were acquired by The Corporation of the District of Burnaby from Phillip Campbell and Mary K. Campbell, both deceased, under authority of By-law No. 759 of the Corporation.

AND WHEREAS John Douglas Hall, Carpenter, of 2630 McKee Street in the Municipality of Burnaby, Province of British Columbia, has offered to purchase the said lands for the sum of Five hundred and fifty (\$550.00) dollars on terms hereinafter mentioned, and it is desirable to accept the said offer.

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby RESOLVES as follows:-

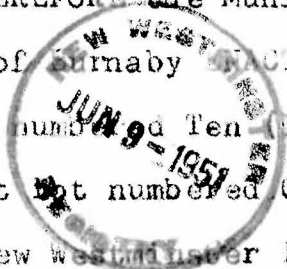
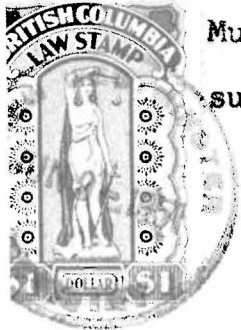
1. That Lot number Ten (10) of Block numbered Twenty two (22), of District Lot numbered One hundred and fifty nine (159), Group One (1), New Westminster District, Map No. 1241 shall be sold to John Douglas Hall, Carpenter, of 2630 McKee Street in the Municipality of Burnaby, Province of British Columbia, for the sum of Five hundred and fifty (\$550.00) dollars payable as follows:-

Two hundred and Seventy five (\$275.00) dollars on the execution and delivery of the Agreement for Sale herein mentioned.

The sum of Twenty (\$20.00) dollars on the Fifteenth (15th) day of July, 1951 and on the Fifteenth (15th) day of each and every month thereafter, with interest on the purchase money from time to time remaining unpaid at the rate of Six (6%) per cent with each instalment.

2. An Agreement for Sale and purchase of the said lands in the terms hereinbefore mentioned shall be executed under the Seal of the Corporation by the Reeve and Clerk.

3. Upon payment by the purchaser of the purchase money aforesaid and on compliance with the terms of the said Agreement for Sale Conveyance of the said lands shall be executed under the Corporate Seal of The Corporation of the District of Burnaby by the Reeve and



Clerk and delivered to the said John Douglas Hall.

4. This By-law shall take effect on its being finally passed.

5. This By-law may be cited as "PHILLIP AND MARY CAMPBELL PROPERTY SALE BY-LAW 1951."

RECONSIDERED AND FINALLY PASSED this Fourteenth (14th) day of May, A.D. 1951.

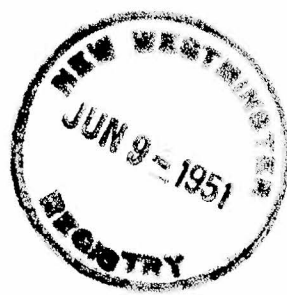
