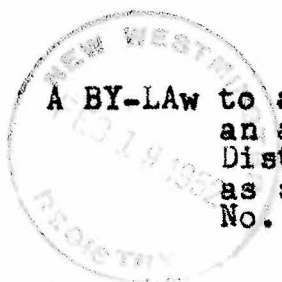
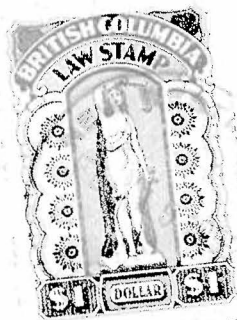


THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 3177



A BY-LAW to authorize the sale of Part 0.128 of an acre more or less of Lot 4, Block 50, District Lot 151, Group 1, Map No. 799, as shewn outlined in Orange on Sketch No. 5515, New Westminster District.

WHEREAS The Corporation of the District of Burnaby has acquired all and singular that certain parcel or tract of land and premises known as Part 0.128 of an acre more or less of Lot Four (4) of Block Fifty (50) of District Lot One hundred and fifty one (151), Group One (1), Map 799, as shewn outlined in Orange on Sketch deposited No. 5515, New Westminster District, for Corporate purposes.

AND WHEREAS the said lands and premises are no longer required for Corporate purposes.

AND WHEREAS the value of the said lands and premises does not exceed the sum of Two thousand (\$2,000.00) dollars.

AND WHEREAS the persons hereinafter mentioned has offered to purchase the said lands for the consideration herein-after mentioned.

AND WHEREAS pursuant to Section 43 (a) of the "District of Burnaby Debt Refunding Act, 1940" the approval of the Honourable, the Minister of Municipal Affairs, is required before any of the capital assets of the Corporation may be disposed of:

AND WHEREAS the Honourable, the Minister of Municipal Affairs, has on the 19th day of March, 1951, granted approval for the sale of the hereinafter mentioned lands and premises.

NOW THEREFORE the Municipal Council of The Corporation of the District of Burnaby ENACTS as follows:

1. That Part 0.128 of an acre more or less of Lot Four (4) of Block Fifty (50) of District Lot One hundred and fifty one (151) Group One (1), Map No. 799, as shewn outlined in Orange on Sketch deposited No. 5515, New Westminster District, be sold and disposed of to Herbert George Haskins, 3139 Kingsway, in the Municipality of Burnaby, Province of British Columbia, for the sum of One thousand four hundred and fifty (\$1,450.00) dollars.

2. That upon the payment of the said sum of One thousand four hundred and fifty (\$1,450.00) dollars by the said Herbert George Haskins, conveyance to the said Herbert George Haskins of Part 0.128 of an acre more or less of Lot Four (4) of Block Fifty (50) of District Lot One hundred and fifty one (151), Group One (1), Map No. 799, as shewn outlined in Orange on Sketch deposited No. 5515, New Westminster District be executed under the Seal of The Corporation by the Reeve and Clerk and be delivered to the said Herbert George Haskins.

3. This By-law may be cited as the "COLBECK PROPERTY SALE BY-LAW 1952."
