## THE CORPORATION OF THE DISTRICT OF BURNABY

## BY-LAW NO. 3192

A BY-LAW to enable The Corporation of the District of Burnaby to provide for all sums which may be required for the lawful purposes of the Municipality and for School Board purposes, for the year 1952.

WHEREAS it is necessary and expedient to pass a By-law for the above named purposes:

THE COUNCIL of The Corporation of the District of Burnaby, pursuant to the provisions of the "Municipal Act" and Amending Acts and any other act or acts thereunto enabling, ENACTS as follows:

1. There shall be raised, levied and collected for the year 1952 upon the assessed value of all taxable land and upon Sixty per centum (60%) of all taxable improvements in the said Municipality of Burnaby as shown upon the last revised Assessment Roll thereof, a tax of Fifty-three (53) mills in the dollar for the following purposes:

(a) to provide, in and for the year 1952, in accordance with the provisions of the "District of Burnaby Debt Refunding Act 1940"

(1) the sum of \$125,000.00 for payment in the first place of interest on Refunding Debentures Series "A" issued under the said Act and thereafter, so far as the balance will thereunto extend for the purchase or redemption of the said Debentures:

(2) the sum of \$10,000.00 to enable the Corporation to make payment of that amount to The Royal Bank of Canada in part satisfaction of the Corporation's indebtedness to the said Bank.

(3) a sum sufficient for payment by the Corporation to the said Bank on and in respect of the said indebtedness, of interest at the rate of  $4\frac{1}{4}\%$  per annum, payable half-yearly on the 2nd day of January, 1953 and on the 2nd day of July, 1952, Three and seventy-three one hundredths (3.73) mills in the dollar by way of a special rate to be known as the "MUNICIPAL LOAN RATE".

(b) To provide for the general purposes of the Municipality Twelve and eighty-one one hundredths (12.81) mills in the dollar to be called the "GENERAL RATE".

(c) To provide for the general purposes of the Board of School Trustees of Burnaby, Thirty and nineteen one hundredths (30.19) mills in the dollar to be called the "SCHOOL RATE".

(d) To provide for the payment of the proportion of the estimate for 1952, of the Vancouver and Districts Joint Sewerage and Drainage Board, One and seventy-five one hundredths (1.75) mills in the dollar to be called the "VANCOUVER AND DISTRICTS JOINT SEWERAGE AND DRAINAGE RATE".

(e) To provide for the payment of the sum of \$93,800.00 being principal and interest payable in the year 1952 on the debt created by By-laws Nos. 2049, 3019 and 3083 of The Corporation, Two and fifty-six one hundredths (2.56) mills in the dollar to be called the "SCHOOL LOAN RATE".

(f) To provide for the payment of the sum of \$24,000.00 being principal and interest payable in the year 1952 on the debt created by By-law No. 3020 of The Corporation, Sixty-six one hundredths (.66) mills in the dollar to be called the "HOSPITAL LOAN RATE".

(g) To provide for the payment of the sum of \$47,640.00 being principal and interest payable in the year 1952 on the debt created by By-law No. 3082 of The Corporation, One and three tenths (1.3) mills in the dollar to be called the "WATERWORKS LOAN RATE".

2. There shall be raised, levied and collected for the year 1952 upon the assessed value of the land and upon Sixty per centum (60%) of improvements in the said Municipality of Burnaby as shown upon the last revised Assessment Roll

thereof, a tax of five (5) mills in the dollar to be called the "FIRE RATE".

3. There shall be raised, levied and collected for the year 1952 upon the assessed value of land in the Willingdon Heights District Improvement area as defined by By-law No. 2026 of The Corporation a tax of Fifty-one and thirty-five one hundredths (51.35) mills in the dollar for the following purpose:

(a) To provide for principal and interest on \$112,400.00 debentures issued by the said Municipality, Fiftyone and thirty-five one hundredths (51.35) mills in the dollar to be called the "WILLINGDON HEIGHTS DISTRICT IMPROVE-MENT RATE".

4. There shall be raised, levied and collected for the year 1952 upon the assessed value of land in the District Improvement area as defined by By-law No. 3145 of the Corporation a tax of Fifty-seven and ninety-one one huldredths (57.91) mills in the dollar for the following purpose:

(a) To provide for principal and interest on
\$125,000.00 debentures issued by the said Municipality,
Fifty-seven and ninety-one one hundredths (57.91) mills in
the dollar to be called the "CASCADE HEIGHTS DISTRICT IMPROVEMENT RATE".

5. There shall be raised, levied and collected for the year 1952 upon the assessed value of land in the District Improvement area as defined by By-law No. 3146 of The Corporation a tax of Seventy-three and two one hundredths (73.02) mills in the dollar for the following purpose:

(a) To provide for principal and interest on
\$53,000.00 debentures issued by the said Municipality,
Seventy-three and two one hundredths (73.02) mills in the
dollar to be called the "WILLINGDON HEIGHTS EXTENSION DISTRICT
IMPROVEMENT RATE".

6. The said Taxes and special rates shall be payable to the Collector, at the Municipal Hall, South Burnab;, of the said Municipality.

7. Provided, however, anything hereinbefore contained to the contrary notwithstanding the sum of One (\$1.00) dollar shall be the minimum taxation upon any parcel of taxable land upon the assessment roll of the Municipality.

8. This By-law may be cited as the "BURNABY REVENUE BY-LAW 1952."

DONE AND PASSED in Open Council the Fifteenth (15th) day of April, A.D. 1952.

RECONSIDERED AND FINALLY PASSED by a three-fourths majority of the Muncipal Council on the Twenty-first (21st) day of April, A.D. 1952.
